the following business was transacted:

- 1. The meeting was opened with prayer by Commissioner W. C. Royle.
- 2. The Minutes of the Regular Meeting of December 17 were read and approved.
- 3. A. K. Anderson, City Building Inspector, explained the plastic sign to be erected at Timberland Drive and Lufkin Avenue, such sign indicating the direction to the down town section of the City. The City Manager was authorized to purchase and install such sign, provided the cost of it does not exceed \$239.00.
- 4. Commissioner Lynn Metteauer made a report on Van Street. This Committee recommended that such street be 39 feet wide at it's entrance to Lufkin Avenue; that the curb be moved East 17 feet on the West side, and that the curb on the East side be moved one (1) foot West, making the entrance to said Street 38 feet between curbs. It was also agreed and voted that the property owner on the West side of the street pay for the curb on that side, and that the City would pay for the curb on the East side. This relocation of Van Street was conditioned that the triangular strip of property just West of the new location would be improved within one year by the owner thereof.
- 5. The Stop Sign Ordinance was passed on first reading.
- 6. The codification of the ordinances and resolutions was discussed. The City Manager and City Secretary reported such work had already begun, and that the ordinances and resolutions were being placed in seperate volumes from the Regular Minutes of the Commission.
- 7. The City Manager was authorized to install stop signs on Fourth Street, for the regulation of traffic thereon.

- 8. The Piney Woods Chapter of the Texas Society of Professional Engineers, at a prior meeting passed a resolution recommending that the City Planning Commission be appointed and that a master plan for the City of Lufkin be prepared and followed.
- 9. The City Manager gave a comprehensive Progress Report on various items of work he has completed, and that is being done at the present time. Such report was appreciated by the Commission, and the City Manager stated that he would give such a report monthly hereafter.
- 10. There being no further business to come before the Commission, the meeting adjourned.
