5. / Mayor W. M. Glenn being absent, upon motion of Commissioner R. E. Melvin, seconded by Commissioner W. D. Winston, Jr., Commissioner G. E. Barington was duly elected mayor pro-tem.

 $\leq$  9. The meeting was called to order by Mayor protem G. E. Barington and the first matter to come before the meeting was Ollie Strain for a license to operate another taxicab, he already having a license to operate three. Curtis Fenley appeared in behalf of the other taxi companies in the city and protested the granting of the application, but the matter was held up until some future date. The main objection seemed to be that Mr. Strain misrepresented the ownership of the taxi company when he first made application for permit.

53. A committee from the Chamber of Commerce appeared before the Council with Ernest Medford as spokesman. Mr Medford stated that the Chamber of Commerce wished to recommend that the matter of building a city hall be deferred for at least one year in order that the finances of the city be in such condition to include an muditorium in the city hall with a seating capacity of at least 1500

\$4. Representatives of the Tyler Transit Company appeared before the Council and Mr. Brown went into detail as to the type and quality of operation which they proposed to furnish. He stated that they would operate two new buses regularly and would more than likely have more than one extra bus for emergency. He stated that theywould want at least a 10 year franchise and that he and Mr. Curry would begin the operation of the company as a partmership but that he expected to incorperate later on. Mr. Brown stated that it would require at least 60 days to begin operation. The Gity Attorney was instructed to draw up a franchise and present it to the bus company for approval.
