being present, and the following absent: NONE constituting a quorum when the following business was transacted:

- Upon motion of W. D. Winston, Jr., seconded by R. E. Melvin, with all commissioners voting AYE, the Estimate Number To of Reynolds & Sutton for \$947.94 was approved and ordered paid.
- 2. The next order of business was the taxi cab controversy which arose after the meeting of February 4th. Mr. James Moore appeared in behalf of James Harrison who had filed application to operate permits number 8 and 9, and Mr. Laird appeared again in behalf of Frank Lee Autin. After a full discussion, upon motion of G. E. Barington, seconded by W. D. Winston, Jr., taxi cab permits 8 and 9 were cancelled, all commissioners voting AYE.
- In Mr. C. L. Duruy addressed the council on the by-pass question and objected to running the highway down Chestnut Street or any other place so that it would cause a loss in business on First Street. He favored widening of First Street and then opening up Second and Third Streets. Dr. Taylor approved Mr. Duruy's recommendations. Mr. Nabors outlined the proposed activities of the Highway Department with reference to Highway 59 and stated that his Department believed it was necessary to do something to relieve congested traffic through Lufkin.

The airport committee from the Chamber of Commerce, represented by Mr. Pinkerton, Mr. Drew and Mr. Beaumier requested consideration of the moving of the radio station to the airport. Upon motion of G. E. Barington, seconded by W. D. Winston, Jr. the proposed move was authorized.

There being no further business to come before the meeting, it was, upon motion duly made and carried, adjourned.
