constituting a quorum when the following business was transacted:

1. The Mayor announced this date had been set for public hearing on the proposed City budget for 1943-44.

2. No one ~~appeared to~~ ~~question~~ the budget as published and on motion of R.E.Melvin, second by Arthur Temple, Jr. and carried by all members voting yea, the ordinance providing for adoption of the ~~ordinance~~ Budget as published was passed on first reading.

3. Mr. Kelley recommended the employment of Miss Billie Mae Gibbs at \$60.00 per month for ninety days as stenographer in the City Attorney's office in order to carry out an intensive effort at collection of delinquent taxes.

<sup>A</sup> Employment of Miss Gibbs was approved on motion of R.E.Melvin, second by B.F.Milligan, all ~~members~~ voting yea.

4. Motion was made by Jas. Abney, second by B.F. Milligan authorizing the purchase of three ceiling fans offered by Judson Coward for \$95.00, provided they will answer the requirements for use in City Hall.

<sup>A</sup> Motion carried by all members voting yea.

5. Captain J.C.Green and Sam Robinson were present and made request that the City resume payment of \$25.00 per month toward taking care of expenses of the local Texas State Guard organization.

<sup>S</sup> Motion was made by R.E.Melvin, second by B. F. Milligan and carried by all members voting yea authorizing this expenditure.

6. The matter of distributing maps and books showing the proposed City plan was discussed and it was the opinion of the Commission that these should be kept on file in the City office for ready reference and inspection by any one interested but if copies were wanted for use at other places the cost of printing should be charged for them.

Nothing further was presented for attention and the meeting was recessed to June 9th at 9:30 AM.
