AN ORDINANCE APPROVING AND ADOPTING A BUDGET FOR THE CITY OF LUFKIN, TEXAS, FOR THE FISCAL YEAR ENDED MARCH 31, 1944, AND FIXING THE EFFECTIVE DATE HEREOF

WHEREAS, in accordance with the laws of the State of Texas, and the Charter of the City of Lufkin, the City Manager ... of the City of Lufkin prepared and submitted to the City Commission of said City a proposed budget for the fiscal year ended March 31, 1944; and,

WHEREAS, a Public Hearing was had on the 7th day of June, A. D. 1943 pursuant to notice published in the Lufkin Daily News, a newspaper published in Lufkin, Angelina County, Texas, as shown by the affidavit of the publisher attached hereto and made a part hereof; and,

WHEREAS, the City Commission, as said public hearing, discussed said proposed budget and sufficient time was given to hearing protests and objections, oral and written, to items in the budget and to omissions therefrom;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS:

SECTIONIL. That the budget of the City of Lufkin, Texas, for the fiscal year ended March 31, 1944, as the same has been prepared and submitted to the Commission by the City Manager, be, and the same is hereby approved and adopted.

SECTION 2. That a copy of said Budget shall be filed with the County Clerk of Angelina County, Texas and with the State Comptroller at Austin, Travis County, Texas.

SECTION 3. That a copy of said budget be placed in the minutes of the meetings of the City Commission of the City of Lufkin, Texas and be available for the inspection of any taxpayer.

SECTION 4. That this ordinance shall become effective in accordance with the Charter of the City of Lufkin, Texas, in such cases made and provided.
