

MINUTES OF A CALLED MEETING OF THE CITY COMMISSION
OF THE CITY OF LUFKIN, TEXAS, HELD ON MAY 29, 1946
AT 3:00 P. M.

On this, the 29th. day of May, 1946, A. D., the City Commission of the City of Lufkin, Texas, convened in a called session, in the regular meeting place in said City, with the following members thereof to-wit:

being present, with L. C. Martin and E. A. Gibbs, Commissioners absent, thus constituting a quorum when the following business was transacted:

1. Mr. J. R. Duke and Mr. Youngblood, residents of Highway 69 were present and requested that the Zone change of John Mason adjoining their property not be made. They stated that they felt that they spoke the sentiments of all the residents in that community when they thought that using this property for a garage and wrecking yard would be unsanitary and unsightly and that it would depreciate their property. Motion was then made by D. M. Thrash and seconded by B. F. Milligan to reject the application. The motion carried by unanimous vote.

2. Upon motion of B. F. Milligan and seconded by D. M. Thrash all other Zone changes were accepted as advertised for public hearing for this date. The motion carried by unanimous vote.

3. E. J. Conn appeared in the interest of a paving lein held by the City against ~~Lot~~ A44, Block of the Zeagler-Cochran-Allbritton Addition and owned by Mrs. Nola Allbritton. Mr. Conn stated that Mrs. Allbritton wished to sell the property but could not unless the lein was released. He further stated that he did not think that the judgement could be collected and that Mrs. Allbritton would pay all City Taxes on the Property. Upon recommendation of the City Attorney, motion was made by D. M. Thrash and seconded by B. F. Milligan to release the judgement. The motion carried by unanimous vote.

4. D. O. Wallis and F. L. Callaway were present and asked for permission for use of the City Warehouse for the National Guard, in event that Lufkin secured a Unit under the terms that the State Defense Guard now uses it and provided the Defense Guard was disbanded. They also requested the help of the City in securing a permanent building site for the National Guard. The matter was discussed after which motion was made by B. F. Milligan and seconded by D. M. Thrash to let the National Guard use the Warehouse as a temporary location and assist them in getting a permanent building site. The motion carried by unanimous vote.

5. An application for permit to rebuild a service station at Keltys and O'Quinn streets from S. T. Lewis was read and upon motion of D. M. Thrash and seconded by B. F. Milligan the permit was granted by unanimous vote.

6. It was then moved by B. F. Milligan and seconded by D. M. Thrash that the City Commission draw up a resolution adopting the proposed locations of Highways 59, 69 and 94 and submitted to State Highway Department. The motion carried by unanimous vote.

No further business was presented, so the meeting adjourned.
