

MINUTES OF A CALLED MEETING OF THE CITY COMMISSION
OF THE CITY OF LUFKIN, TEXAS HELD ON APRIL 18, 1947,
AT 7:30 P. M.

On this, the eighteenth day of April, 1947, A. D., the City Commission of the City of Lufkin, Texas met in a called meeting in the regular meeting place in the said City with the following members, thereof, towit:

being present, with none absent, thus constituting a quorum, when the following business was transacted:

(A number of petitions signed by a group of people residing within one-half of the city limits and requesting annexation to the City was presented to the Council for consideration. An affidavit signed by H. J. Shands, R. M. Feagin, Eddie Bryant, O. L. Finley, and James H. Butler, Jr. was presented and declared that a majority of the citizens living in the affected area and qualified to vote had signed and requested annexation. The following action was taken concerning an ordinance to receive and annex the area:

Commissioner L. C. Martin moved that the ordinance be placed on first reading; seconded by Commissioner D. M. Thrash, and carried by the following vote:

Yea: L. C. Martin , D. M. Thrash , C. C. Sinclair ,

Nay: G. W. Roland , Granville Wright

Carried: Ordinance placed on first reading.

Commissioner D. M. Thrash moved that the ordinance pass first reading; seconded by Commissioner L. C. Martin and carried by the following vote:

Yea: L. C. Martin , D. M. Thrash , C. C. Sinclair ,

Nay: Granville Wright , G. W. Roland

Carried: Ordinance passed first reading.

Commissioner C. C. Sinclair Moved that the rules be suspended and that the ordinance be placed on second and final reading; seconded by Commissioner L. C. Martin and carried

by the following vote:

Yea: C. C. Sinclair, L. C. Martin, D. M. Thrash,

Nay: B. W. Roland, Granville Wright.

Carried: Ordinance placed on second and final reading.

Commissioner D. M. Thrash moved that the ordinance pass second and final reading, seconded by Commissioner L. C. Martin and carried by the following vote:

Yea: L. C. Martin, D. M. Thrash, C. C. Sinclair,

Nay: Granville Wright, G. W. Roland.

Carried: Ordinance passed second and final reading. The Mayor then declared the ordinance finally passed.

2. The following zone change applications were read:

W. K. Modrall, James A. Hackney, E. J. Conn, H. D. Green, O. V. Tatum. All applications had been previously approved by the Zoning Board. Approval for advertisement for public hearing April 29, at 3:30 P. M., was made.

3 Mr. F. L. Calloway was present and requested that Lots "E" and "D", Block One of the Townsend Addition be removed from the fire limits in order that he may be permitted to erect a Quonset hut on the lots. He was told that the matter would be advised later.

4 It was then moved by L. C. Martin and second by G. W. Roland that an operator's tax be placed on all marble machines and electric record players receiving coins. The motion carried and the City Attorney instructed to prepare the ordinance.

5 An application from H. A. Hayley and J. F. Lamon requesting the closing of a dead end alley running east and west in Block Two of the Treadwell Addition. ^{WAS READ} Mr. Hayley and Mr. Lamon were the only property owners abutting this alley and it was moved by G. W. Roland and second by C. C. Sinclair that the alley be closed. The motion carried by unanimous vote of yea.

No further business was presented so the meeting adjourned.
