The following proceedings, among other matters, were disposed of by the Council:

/. Bids on Street Sweeper opened.

Rhinehart Texas Equipment Co, Dallas; Elgin Sweeper \$9,530.00 delivered to Lufkin within 30 days.

Gaddy Machinery Co., Austin; Wayne Sweeper \$8,517.00 delivered to Lufkin within 10 days.

Highway Equipment Co., Houston; Austin-Western Sweeper \$7,181.50 delivered to Lufkin immediately.

After a discussion by Representatives of each company as to the merits of their respective street sweeping machines and a statement from Mr. Adams, Representative of the Highway Equipment Company, that the Austin-Western Street Sweeper would pick up and hold and deliver a load of two cubic yards of dirt and trash, and the City having advertised for bids specifying that said street sweeper must hold and carry at least two cubic yards of dirt from the street and dump same at appropriate dumping places, thereby enabling the City to operate within its economy budget, a motion was made by L. C. Martin and seconded by Joe Stegall to purchase an Austin-Western Sweeper, provided such sweeper would do the work as specified in bids and as stated by Mr. Adams that said street sweeper would do. All present voted "Yes".

- 2 Motion made by L. C. Martin and seconded by Joe Stegall to pay all bills listed. All present voted "Yes".
- 3 Motion made by Joe Stegall and seconded by L. C. Martin to authorize the Mayor and Acting Secretary to execute note for \$3,500.00 as cash payment on Sweeper; also to sign Contract to Highway Equipment Company for \$3,681.00 at 4 per cent payable one year from date.
- 4 Motion made by L. C. Martin and Seconded by Joe Stegall to pay Community Grocery for water paid at \$5.00 per month that should have been paid at \$2.00 per month. Refund \$3.00 per month. All present voted "Yes".
- Motion made by L. C. Martin and seconded by Joe Stegall to finance Water & Sewer Lines extention at 4 per cent interest, payable \$40.00 per year. All present voted "Yes".

Motion carried to adjourn.
