

MINUTES OF REGULAR MEETING OF THE CITY
COMMISSION OF THE CITY OF LUFKIN,
TEXAS, HELD NOVEMBER 18, 1952
AT 7:30 P.M.

On this the 18th of November, A.D., 1952, the City Commission of the City of Lufkin, Texas, convened in regular session in the regular meeting place in said City, with the following members thereof being present:

A quorum being present, the following business was transacted:

1. Mr. A.O. McQueen appeared before the Commission in behalf of The Lufkin Municipal Airport. Mr. McQueen advised the Commission that the port was no more a profitable enterprise, due to the fact that practically all transient traffic was using The County Airport at Burke, Texas, and that he was loosing about \$100.00 per month in keeping The City Airport open. He asked that the Commission act to close The Municipal Port to transient traffic. On Motion of Commissioner Zeagler and seconded by Commissioner Stegall, the Commission voted unanimously to close The Lufkin Municipal Airport and instructe City Attorney Brazil to transmit letter of authority to Mr. McQueen.

2. The Council received three application for Zone changes:

1. Application of C.C. Lowery, Jr. for Zone change from "A" District to "F" District on Tract No. 1, 1.669 acres of land, a portion of the C.C. Lowery 14.1 acre homestead tract, being Tract No. 33, Map 8, of the Map of City of Lufkin, Texa
2. Application of the Central Baptist Church by its Board of Trustees, for Zone change from "A" District to "B" District on Tract No. 2 of the C.C. Lowery Homestead Tract, containing 1.669 acres, and being Tract 32, Map 8 of the Map of City of Lufkin, Texas.
3. Application of W.A. Williford for Zone change from "A" District to "F" District on Part of Tract 35, Map No. 6, of the Map of the City of Lufkin, Texas, being a portion of the M.M. McMullen homestead tract of land.


Upon motion of Commissioner Stegall and seconded by Commissioner Zeagler. The Commission voted unanimously for passage of these application for publication and Public Hearing at its regular meeting on the first Tuesday in December, 1952.

3. Mr. Clyde Jordan appeared before the Council with drainage problem on Lot 1, Block 22, of the Angelina County Lumber Company Subdivision located on Branch Street. After much discussion the problem was deferred until more information could be furnished by City Engineer.


4. Mr. Grover Atkinson was present and received an agreement executed by the City covering easement on drainage ditch
