the following business was transacted:


1. The meeting was opened with prayer by Mayor, S. R. Parker, Jr.
2. The minutes of the regular meeting of June the 4th were read and approved.
3. The contract with Freese, Nichols & Turner, as corrected, to make a survey of the needs of the Lufkin Sewage System and Disposal Plant, was approved and the Mayor was authorized to sign such contract.
4. Moroney & Morris, attorneys, were given a contract to collect delinquent taxes, such contract ending June 30, 1959.
5. Ross Gipson and D. C. Cullwell, members of the Equalization Board, appeared before the Commission and discussed tax values of property within the City.
6. W. F. Collins was elected Mayor pro tempore to act in the absence of the Mayor.
7. The statement for the month of June, by Freese, Nichols & Turner, was approved, upon the recommendation of the City Manager.
8. Zone application of Mrs. Arnold Betts, Mrs. Elizabeth Stroud and Mrs. Willie Renfrow to change the zone from "F" District to "H" District on a portion of Lot No. One (1),

and the South portion of Lot No. Two (2), in Block No. Fifty-one (51), of the Denman Addition, and on Tract Thirty (30), Map Twenty-four (24), City of Lufkin was ordered published, for final hearing July 16, 1957.

9. A water and sewer rate ordinance fixing new water and sewer rates, both inside and outside the City Limits, was passed on first reading.
10. An amemdment to the trash and garbage ordinance changing rates was passed on first reading.
11. Bills for the month of May were approved and ordered paid.
12. There being no further business to come before the Commission, the meeting adjourned.
