1. Meeting was opened with prayer by City Manager Harvey Westerholm.

2. CANVASS OF ELECTION RESULTS

Mayor Bronaugh stated that the City Commission had met to canvass the results of the Tax Rollback Election held Saturday, January 21, 1989.

Mayor Bronaugh stated that Commissioner Bob Bowman was out of town and Commissioner Jack Gorden had been called to a special board meeting at the bank.

Mayor Bronaugh stated that the TML Legislative Update had been passed out to members of the Commission giving names of senators who are Chairmen of various committees. Mayor Bronaugh stated that Rep. Billy Clemons is Vice Chairman of the Health and Welfare Committee and serves on the Transportation Committee.

5. COMMENTS

Commissioner Percy Simond expressed concern that the City obviously did not have the total support of its employees and suggested that the Commission take a strong, hard look at the increase in wages for City employees.

Commissioner Danny Roper stated that the subject of devisiveness has somehow entered into this process. Commissioner Roper stated that the Commission can go forward and do a good job.

Commissioner Paul Mayberry stated that there is kind of an unwritten rule not to take away what has been given to employees. Commissioner Mayberry stated that it would be disruptive to take raises away from City employees.

Commissioner Simond stated that Commissioners Mayberry and Bowman let their feelings be known about the rollback but nobody else made a real effort. Commissioner Simond stated that, in his opinion, the City Commission had not supported the City Manager and his staff after they spent months preparing the budget. Mayor Bronaugh stated that he felt the Commission had supported the City Manager and his staff, maybe not in the same form or fashion.
