1. The meeting was opened with prayer by City Manager Keith Wright.

2. RESOLUTION ADOPTING A PROPOSAL TO CONSIDER A TAX RATE THAT WILL RESULT IN ADDITIONAL REVENUES AS OUTLINED IN SECTION 26.05(D) OF THE TAX CODE OF THE STATE OF TEXAS-APPROVED

City Manager Keith Wright stated that when a proposed tax rate exceeds the rollback rate or the effective rate, State law required that the City Council must vote to place a proposal to adopt the rate on the agenda of a future meeting as an action item. City Manager Wright explained that the tax rate would not be adopted on this day, but this agenda item would adopt a proposed rate. City Manager Wright continued that the rate proposed in the Fiscal Year 2015-2016 Operating Budget is \$0.5238 per \$100 valuation, which is higher than the 2014 effective tax rate of \$0.5144. City Manager Wright stated that therefore, Council must vote on a resolution to consider raising the tax rate. City Manager Wright concluded that Staff recommended City Council approve a Resolution adopting the proposed tax rate.

Councilmember Lynn Torres made a motion to approve the Resolution adopting a proposed tax that would result in additional revenues as outlined in Section 26.05(D) of the Tax Code of the State of Texas. Councilmember Sarah Murray seconded the motion. A roll call vote was taken with Mayor Bob Brown and Councilmembers Victor Travis, Robert Shankle, Lynn Torres, Rocky Thigpen, and Sarah Murray voting aye. Councilmember Mark Hicks was absent.
