Councilmember Lynn Torres moved to approve all items on the consent agenda as presented. Councilmember Robert Shankle seconded the motion and a unanimous vote to approve was recorded.

#### **BUSINESS AGENDA**

### 18. PUBLIC HEARING AND FIRST READING OF AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF LUFKIN, TEXAS CHANGING THE ZONING TO "MANUFACTURED DWELLING" ON PROPERTY ADDRESSED AS 2206 NILE STREET - APPROVED

City Manager Bruce Green stated the applicant, Jewitt Thompson III had requested a zone change from "Residential Small" to "Manufactured Dwelling" for 2206 Nile Street. City Manager Green highlighted the location of the property on the corresponding maps and provided information on the current zoning of the neighboring properties. City Manager Green stated the Comprehensive Plan designation for the property was "Low Density Residential". City Manager Green furthered the purpose of the zone change was to replace the current site-built home with a manufactured home. City Manager Green stated the request was unanimously approved by the Planning and Zoning Commission during the June 14, 2021 meeting. City Manager Green concluded Staff recommended City Council conduct a Public Hearing and consider approval of the First Reading of an Ordinance changing the zoning to "Manufactured Dwelling" on property addressed as 2206 Nile Street.

Mayor Hicks opened the Public Hearing at 5:05 p.m. There being no one who wished to speak, Mayor Hicks closed the Public Hearing and requested comments from City Council.

Councilmember Guessippina Bonner moved to approve the Ordinance as presented. Councilmember Robert Shankle seconded the motion and a unanimous vote to approve was recorded.

# 19. PUBLIC HEARING AND FIRST READING OF AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF LUFKIN, TEXAS CHANGING THE ZONING TO "RESIDENTIAL LARGE" AND THE FUTURE LAND USE MAP DESIGNATION TO "LOW DENSITY RESIDENTIAL" ON PROPERTY ADDRESSED AS 303 PONDEROSA - APPROVED

City Manager Bruce Green stated the applicants, Ray Gene Brown Jr. and Cheryl Ellen Lee, had requested a zone change from "Commercial" to "Residential Large" for 303 Ponderosa Drive. City Manager Green furthered the item also included a future land use plan map change from "Low Density Residential" and "Corridor Commercial" to a singular "Low Density Residential" classification. City Manager Green highlighted the location of the property on the corresponding maps and provided information on the current zoning of the neighboring properties. City Manager Green furthered the purpose of the zone change and the associated future land use plan map change was to retain the residential aspect and quality of life of the applicant's single-family residence. City Manager Green stated by changing the property to "Residential Large", the subject property would be given added protections including requiring solid fencing on neighboring properties for which a non-residential use is permitted. City Manager Green furthered the Planning and Zoning Commission unanimously approved the request during the June 14, 2021 meeting. City Manager Green concluded Staff recommended City Council conduct a Public Hearing and consider approval of the First Reading of an Ordinance changing the zoning to "Residential Large" and the Future Land Use map designation to "Low Density Residential" on property addressed as 303 Ponderosa.

Mayor Hicks opened the Public Hearing at 5:09 p.m. There being no one who wished to speak, Mayor Hicks closed the Public Hearing and requested comments from City Council.

Councilmember Rocky Thigpen moved to approve the Ordinance as presented. Councilmember Lynn Torres seconded the motion and a unanimous vote to approve was recorded.

# 20. PUBLIC HEARING AND FIRST READING OF AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF LUFKIN, TEXAS CHANGING THE ZONING TO "LOCAL BUSINESS" AND THE FUTURE LAND USE MAP DESIGNATION TO "NEIGHBORHOOD COMMERCIAL" ON PROPERTIES ADDRESSED AS 1510 AND 1512 SOUTH CHESTNUT STREET - POSTPONED

City Manager Bruce Green stated the applicant, Ellen Christine Loden Davis, had requested a zone change from "Residential Large" to "Local Business" for 1510 and 1512 South Chestnut Street. City Manager Green furthered the request would also include a Future Land Use Map change from "Medium Density Residential" to a "Neighborhood Commercial" classification. City Manager Green highlighted the location of the property on the corresponding maps and provided information on the current zoning of the neighboring properties. City Manager Green stated the request was unanimously approved by

the Planning and Zoning Commission during the meeting of June 28, 2021. City Manager Green concluded Staff recommended City Council conduct a Public Hearing and consider approval of the First Reading of an Ordinance changing the zoning to "Local Business" and the Future Land Use Map designation to "Neighborhood Commercial" on properties addressed as 1510 and 1512 South Chestnut Street.

Mayor Hicks opened the Public Hearing at 5:12 p.m. Mr. Michael Parker, resident of the neighborhood located behind the property spoke against the requested zone change. Mr. Lee Miller, applicant, and Mrs. Brenda Rhodes, realtor, spoke in support of the proposed zone change. There being no one further who wished to speak, Mayor Hicks closed the Public Hearing and requested comments from City Council.

Councilmember Guessippina Bonner moved to postpone consideration of the Ordinance in order to allow both parties to discuss and come to an agreement. Councilmember Wes Suiter seconded the motion and a unanimous vote to postpone was recorded.

## 21. <u>PUBLIC HEARING AND FIRST READING OF AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF LUFKIN, TEXAS CHANGING THE ZONING TO "COMMERCIAL" ON PROPERTIES ADDRESSED AS 4600 SOUTH MEDFORD DRIVE AND 1915 SOUTH FIRST STREET - APPROVED</u>

City Manager Bruce Green stated the applicant, Jeff S. Chance, on behalf of Lufkin GKD Partners LP and Lufkin Investment Partners LLC had requested a zone change from "Residential Large" to 'Commercial" on properties commonly known as the Lufkin Mall. City Manager Green stated that the purpose of the zone change was simply to promote the marketing of the Mall.

Mayor Hicks opened the Public Hearing at 5:34 p.m. Attorney Jeff Chance spoke on behalf of the applicant and stated he would be glad to answer any questions. There being no one further who wished to speak, Mayor Hicks closed the Public Hearing and requested comments from City Council.

Councilmember Lynn Torres moved to approve the Ordinance as presented. Councilmember Robert Shankle seconded the motion and a unanimous vote to approve was recorded.

## 22. PUBLIC HEARING AND FIRST READING OF AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF LUFKIN, TEXAS CHANGING THE ZONING TO "COMMERCIAL" ON PROPERTIES ADDRESSED AS 1816 ATKINSON DRIVE AND 411 OLETA STREET - APPROVED

City Manager Green stated that the applicants Jose and Araceli Madera had requested a zone change to "Commercial" for the properties as described and shown on the map for use as an automotive sales location. City Manager Green detailed the surrounding properties and their uses.

Mayor Hicks opened the Public Hearing at 5:37 p.m. There being no one who wished to speak, Mayor Hicks closed the Public Hearing and requested comments from City Council.

Discussion ensued regarding the effect of an automotive sales business at the location. Councilmember Burfine asked for clarification on the size of the property. Councilmember Bonner expressed her disagreement with the proposed use of the property.

Councilmember Lynn Torres moved to approve the Ordinance as presented. Councilmember Robert Shankle seconded the motion and a unanimous vote to approve was recorded.

## 23. <u>PUBLIC HEARING AND FIRST READING OF AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF LUFKIN, TEXAS CHANGING THE ZONING TO "LOCAL BUSINESS" ON PROPERTY ADDRESSED AS 707 WEST FRANK AVENUE - APPROVED</u>

City Manager Green stated that the applicant, Realtor Angela Williams, on behalf of the owner, Lisa Evans Bullock, had requested a zone change to "Local Business" on the property in order to allow for future development. City Manager Green described the surrounding zoning and businesses in the area adjacent and around the property.

Mayor Hicks opened the Public Hearing at 5:43 p.m. Realtor Angela Williams spoke in favor of the item. There being no one further who wished to speak, Mayor Hicks closed the Public Hearing and

requested comments from City Council. Councilmember Burfine questioned whether the house next door was occupied. City Manager Green stated the house was vacant. Councilmember Bonner spoke in favor of the zone change.

Councilmember Wes Suiter moved to approve the ordinance as presented. Councilmember Rocky Thigpen seconded the motion and a unanimous vote to approve was recorded.

## 24. PUBLIC HEARING AND FIRST READING OF AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF LUFKIN, TEXAS CHANGING THE ZONING TO "COMMERCIAL" AND THE FUTURE LAND USE MAP DESIGNATION TO "REGIONAL RETAIL" ON PROPERTY ADDRESSED AS 122 WHITEHOUSE DRIVE - APPROVED

City Manager Green stated the zone change had been requested to allow the property to be developed for use as a processing warehouse for the Women's Shelter of East Texas. City Manager Green furthered that this item was spoken for during the public comment section of the meeting. City Manager Green detailed the surrounding properties and uses.

Mayor Hicks opened the Public Hearing at 5:52 p.m. Tim Johnson spoke again and stated he would be glad to answer any questions related to the development. Councilmember Rocky Thigpen recused himself from discussion and voting on the item. Councilmember Trent Burfine clarified retention pond requirements for the property. Mr. Johnson detailed the retention pond area and stated it met all requirements for the property in question. There being no one else who wished to speak, Mayor Hicks closed the Public Hearing and requested comments from City Council.

Councilmember Lynn Torres moved to approve the Ordinance as presented. Councilmember Robert Shankle seconded the motion and a unanimous vote to approve was recorded.

## 25. PUBLIC HEARING AND FIRST READING OF AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF LUFKIN, TEXAS CHANGING THE ZONING TO "LOCAL BUSINESS" ON PROPERTY ADDRESSED AS 718 WEST FRANK AVENUE - DENIED

City Manager Green stated that the applicant, Angela Williams, on behalf of the owners, Wade Family Management Trust, requested a zone change to "Local Business" for property located 718 West Frank Avenue. City Manager Green highlighted the area and previous zone changes in the vicinity. City Manager Green stated that this zone change was denied by the Planning and Zoning Commission and due to that; City Council would have to pass the item with a super majority vote, or six (6) out of seven (7) members.

Mayor Hicks opened the Public Hearing at 5:58 p.m. Attorney Don Duran spoke in favor of the item as did property owners Jack Wade, III and Barbara Wade. Applicant Angela Williams also spoke in favor of the item. Mantooth area residents Valena Spradley, Vanessa Childers and Ron Byrd spoke against the item. Resident Jesse Howard and Earnest King, spoke in favor of the zone change. Reverend Lynn Hargrow spoke in agreement with those that were against the request. Residents Veronica Smith and Natalie Howard spoke against the request. There being no one further who wished to speak, Mayor Hicks closed the Public Hearing and moved to comments from the City Council.

Lengthy discussion ensued between City Council and members of the audience concerned with the item. At the conclusion, Councilmember Trent Burfine called for a roll call vote and moved to approve the recommendation of the Planning and Zoning Commission, which was to deny the request. More discussion followed regarding the specifics of the motion made by Councilmember Burfine and the options to the applicant. Councilmember Guessippina Bonner seconded the motion. Councilmember Trent Burfine, Councilmember Guessippina Bonner, Councilmember Wes Suiter voted aye to deny the zone change as requested. Councilmember Lynn Torres, Councilmember Rocky Thigpen, Councilmember Robert Shankle and Mayor Mark Hicks voted to approve the zone change.

Due to the super majority vote requirement, the zone change was denied.

Mayor Hicks called for a brief recess at 6:51 p.m. before moving forward with Item No. 26. Mayor Hicks reconvened the meeting at 6:59 p.m.

### 26. PUBLIC HEARING AND RESOLUTION AUTHORIZING THE LUFKIN POLICE DEPARTMENT TO APPLY FOR A U.S. DEPARTMENT OF JUSTICE FISCAL YEAR 2021

### EDWARD BYRNE JUSTICE ASSISTANCE GRANT IN THE AMOUNT OF \$11,906 - APPROVED

City Manager Green stated that this was a grant request that City Council was familiar with. City Manager Green continued that the Lufkin Police Department and the Angelina County Sherriff's Department was jointly eligible for \$11,906 in funding through this grant program.

City Manager Green concluded that Staff recommended City Council approve the required Resolution and conduct the Public Hearing per the grant regulations.

Mayor Hicks opened the Public Hearing at 7:00 p.m. There being no one who wished to speak, Mayor Hicks closed the Public Hearing and moved to comments from City Council.

Councilmember Wes Suiter moved to approve the Resolution as presented. Councilmember Rocky Thigpen seconded the motion and a unanimous vote was recorded.

### 27. <u>SUBDIVISION IMPROVEMENT AGREEMENT BETWEEN THE CITY OF LUFKIN AND SHIREY FOREST, LLC - APPROVED</u>

City Manager Green stated that this was a development agreement for a subdivision by the name of Shirey Forest, LLC and the owner, Lamar Clarke, was present as well. City Manager Green continued that the agreement would provide for City assistance with the completion of water and sewer infrastructure for the project, which included sixteen (16) lots.

City Manager Green concluded Staff recommended City Council approve the agreement as presented. Councilmember Guessippina Bonner moved to approve the agreement. Councilmember Trent Burfine seconded the motion and a unanimous vote to approve was recorded.
