The City Council of the city of Lufkin Texas met in the Council Chamber in the City Hall in the city of Lufkin Texas on the 19th day of April A.D.1919 with the following named officers present G.A.Kepley, mayor presiding; E.E.Woods, Commissioner of ward # 2 C.B.Edwards, Commissioner of ward # 3 and Dr.W.B.Treadwell, Commissioner of ward # 4. and J.T.Maroney Secretary. Sam R.Parker Commissioner of ward # 2 being absent.

The object of the meeting , as explained by Mayor, G.A.Lelley was to appoint a City Marshal in and for the city of Lufkin Fexas as Mr.T.A.Goode who was appointed to the office of City Marshal by the City Council on the 8th day of April 1919, refused to accept the office and qualify as city marshalk Whereupon it was moved by Dr.W.B.Treadwell , Commissioner of ward # 4 and seconed by Commissioner C.B.Edwards of ward #3 that Non Binion be appointed and elected to the office of Marshal in and for the city of Lufkin Texas .said motion being submitted to the Council ,all the Commissioners present voted in the affirmative; whereupon it was declared by the mayor that the said Non Binion was duly and constitutionly elected to the office of City Marshal in and for the city of Lufkin Texas, at a salary of 15000 per month. It is therefore ordered adjudged and decreed by the City Council of ohe City of Lufkin Texas that Non Binion be and he is hereby appointed and declared City Marshal of the City of Lufkin Texas, and his salary is hereby just at 150° per month. After discussing some other matters pertaining to the welfare of the city theywere left open for further discussion and the Council adjourned, subject to the call of the Mayor.

The City Council of the čity of Lufkin Texas met in called session on this the 29th day of April A.D.1919 with the following named officers present, Mayor , G.A.Kelley presiding; Sam R.Parker, Commissioner of ward # 1;E.E.Woods , Commissioner of ward # 2 C.B.Edwards, Commissioner of ward # 3 Dr.W.B.Treadwell, Commissioner of ward # 4 and JT Maroney , Secretary.

Drs. Van Hoovingburg, Sledsoe and Dunn were present and made talks on the the subject of exterminating mosquitoes out of the town of Lufkin, during the spring and summer months of 1919, Dr. Van Hoovengur representing the St.Louis Southwestern Railroad Company which is now exterminating the mosquitoes out of the several towns and cities on its line of road, said towns and cities bearing a proratta part of the expenses. And after careful consideration of the matter, as presented by the above named physicians, it was moved by Commissioner Edwards and seconed by Commissioner Woods that the Council designate and set spart \$900.00 of the citys funds to pay the citys pro rata part of the expenses of exterminating the mosquitoes out of the city of Lufkin Tex as the work progresses under the supervision of the St.Louis Southwest Railroad Company during the spring and summer months of 1919. It was ordered by the Council that all the old outstanding claims against the city, as presented by Mr.Williams who has just finished auditing the books and accounts of the city , be allowed and paid , to w The Cotton Belt Lumber Companys claim for \$360.04; The Lufkin Foundary and Machine Company, s claim for \$464.04; The Gulf Refining Company, s a car of oil a car of a claim for \$264.25; W.M.Glenn and Company, s claim for \$77.65, and The Germo M.F.& Company, s claim for \$25.43and The Anderson Coupling Company,s claim for \$36.00, aggregating \$1237.43 It was further ordered by the Council that the salaries and per diem pay be allowed and paid the officers and employees of the city for their services during the month of April 1919, to wit; W.L.Jonesmwater Commissioner \$100.00 ; Tom Russell , pumper \$90.00 Will Murry \$70.00; Ike Alexander for 21 days work on the water syster at \$3.00 per day ,\$63.00 \$ Edgar Jones ,fireman for the last half of April \$25.00 Tom Lumley , fireman for the last half of April \$30.00 Non Binion for 10 dats salary as City Marshal \$ 50.00 ; Dr.W.W.Dunn (City Health Officer \$12.50%; P.A.McCarthy City Engineer \$12.50 ; R.H. Hooten , Deputy City Marshal \$25.00
