

NOTICE OF CALL MEETING.


TO THE MEMBERS OF THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS,
CITY MANAGER AND CITY SECRETARY.

I hereby call a meeting of the City Commission of the City of Lufkin Texas, to be held at the Municipal Office on the 5th day of August, A.D. 1920 at 7:30 P.M. for the purpose of taking up and passing on the first reading of the following Ordinances:

AN ORDINANCE REGULATING THE CONSTRUCTION, EQUIPMENT, OPERATION AND CONDUCT OF MOTION PICTURE THEATRES AND ALL FIXTURES AND EQUIPMENT AND APPURTENANCES, AND DEFINING THE DUTIES OF THE CITY INSPECTOR AND FIRE MARSHALL WITH RESPECT THERETO; AND PROVIDING PENALTIES. AN ORDINANCE AMENDING AN SECTION 4 OF AN ORDINANCE ENTITLED "AN ORDINANCE ESTABLISHING AND REGULATING PUBLIC POUNDS AND REGULATION RESTRAINING AND PROHIBITING THE RUNNING AT LARGE OF HORSES, MULES, JACKS, JENNETS, SHEEP, SWINE, GOATS, AND CATTLE, AND AUTHORIZING THE DESTRAINING, IMPOUNDING AND SALE OF THE SAME FOR THE COSTS OF THE PROCEEDINGS AND THE PENALTY INCURRED AND ORDERING THEIR DESTRUCTION WHEN THEY CANNOT BE SOLD; PROVIDING FORFEITURES" PASSED ON THE 9th DAY OF MAY, A.D. 1914. AN ORDINANCE AMENDING SECTION I OF AN ORDINANCE PASSED AND APPROVED ON SECOND READING ON THE 11th DAY OF JUNE A.D. 1920 BY THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS, AND ENTITLED "AN ORDINANCE APPOINTING THE MEMBERS OF THE BOARD OF EQUALIZATION IN AND FOR THE CITY OF LUFKIN FOR THE YEAR A.D. 1920" AND DECLARING AN EMERGENCY. AN ORDINANCE AMENDING SECTION I OF AN ORDINANCE ENTITLED "AN ORDINANCE AMENDING SECTION 9 OF AN ORDINANCE ENTITLED "AN ORDINANCE ESTABLISHING AND REGULATING PUBLIC POUNDS, AND REGULATING, RESTRAINING AND PROHIBITING THE RUNNING AT LARGE OF HORSES, MULES, JACKS, JENNETS, SHEEP, SWINE, GOATS, and CATTLE, AND AUTHORIZING DESTRAINING, IMPOUNDING AND SALE OF THE SAME FOR THE COSTS OF THE PROCEEDINGS AND THE PENALTY INCURRED, AND ORDERING THEIR DESTRUCTION WHEN THEY CANNOT BE SOLD; PROVIDING FORFEITURES" PASSED ON THE 23rd DAY OF APRIL A. D. 1915 AND REPEALING ALL ORDINANCES IN CONFLICT THEREWITH. AN ORDINANCE CREATING THE OFFICE OF CITY INSPECTOR AND FIRE MARSHALL DEFINING THE DUTIES THEREOF AND PLACING THE DUTIES THEREOF AND PLACING THE DUTIES FORMERLY ENJOINED UPON THE CITY ENGINEER AND FIRE MARSHALL UPON SAID OFFICER, REPEALING ALL ORDINANCES IN CONFLICT THEREWITH.

And such other matters as may come before the body.
