Pursuant to the above notice the City Commission met on this the 31st. day of March, A.D.1920, at the Municipal Office thereof, the following officers being present: G. A. Kelley, Mayor, E. E. Woods, Commissioner Ward No. 2, S. R. Parker, Commissioner Ward No. 2, W. B. Treadwell, Commissioner Ward No. 4, and L. Mitchell, City Manager and T. L. Dunn, City Secretary, when the following proceedings were had, to-wit:-

Whereas, the office of Commission of Ward No. 3 is vacant because of the removal from the City of C. B. Edwards, the duly elected Commissioner for said ward No. 3, and said office is hereby declared vacant for the reason as aforesaid.

## AN ORDINANCE.

Whereas, the office of City Commissioner of Ward No. 3 of the City of Lufkin, Texas, had been declared vacant for the reason of the removal from the City, C. B. Edwards, the duly elected Commission from said Ward No. 3

Whereas, the City Commission of the City of Lufkin, Texas, is in situation to fill the vacancy in such office by an election.

Therefore, be it ordained by the City Commission of the City of Lufkin, Texas:

That an election be held within and for the City of Lufkin, Texas, on the 17th day of April, A. D. 1920 for the purpose of elections a Commissioner from Ward No. 3 in and for the City of Lufkin, Texas. That said election shall be held in conformity with the charter of the City of Lufkin, Texas, and general laws of the Sate of Texas applicable thereto.

All qualified electors are qualified to vote at such election. The Ballot for said election shall have written or printed on it the words "Official Ballot" and the names of the candidates.

Shuld any candidate fail to receive a majority of the legal votes at said election, the City Commission shall immediately order a special election to hee held not later than ten (10) days nor more than twenty (20) days after the result of said election has been delcared, at which other election the names only of the two candidates receiving the highest number of votes at the first election shall be printed on the ballot and submitted to the qualified voters. The candidate receiving the majority of the votes shall be declared legally elected.

The following are hereby appointed as acting judges at said election, D. A. Singleton, Sam H. Kerr, H. P. Davis and P. M. Albritton.

Notice of this election shall be given by the Mayor by posting a copy of this ordinance, certified under the hand of the City Secretary, in three (3) public places within said City, one of which shall be at the Fire Station door for ten (10) days prior to said election.

e. E. Woods made a motion to pass and approve the above ordinance on its first reading, and S. R. Parker seconded said motion. The Mayer then put the question and instructed all those Commissioners favoring

the passage of said ordinance to vote "Aye", and those Commissioners opposing the passage of said ordinance to vote "No". The following Commissioners voted "Aye" E. E. Woods, S. R. Parker, W. B. Treadwell, and G. A. Kelley, Mayor. The following Commissioners voted "No"-None. The Mayor then declared the motion carried and the ordinance aforesaid passed and approved on its first reading.

The question of determining and specifying the particular Streets of the City that shall be paved in connection with the paving program now under consideration by the city in which the proceeds of the \$100,000. Bond issue heretofore voted on November 19th, 1919, shall be expended, the following streets are hereby designated for paving, viz:-

Beginning at the present pavement on North First Street; thence running north with said North First Street to opposite the residence of E. E. Woods:

Beginning at the intersection of Howe Avenue and North First Street; Thence East on said Howe Avenue to North Second Street;

Beginning at the intersection of said Second atreet and Howe Avenue; Thence South on Said Second Street to Groesbeck Avenue;

Beginning at the intersection of Groesbeck Avenue and Second Street; Thence East to Chesnut Street with said Groesbeck Avenue;

Beginning at the intersection of Chesnutt Street and Glendale Cemetery Road; thence with said Glendale Cemetery Road to the City limits on said Road.

Beginning at the intersection of North Second Street and Groesbeck Avenue; thence South with said North Second Street to the present pavement on Lufkin Avenue;

Beginning at the present pavement at the intersection of Avenue and North First Street; thence East with said Avenue to its intersection with North Second Street;

Beginning at the intersection of Angelina Avenue with Dozier
Avenue at the present pavement; thence north with said Angelina Avenue
to the intersection of Bremond Avenue;

Beginning at the intersection of Bremond Avenue and Angelina Avenue; Thence North West to the intersection of Culver House Street; thence North on Culver House Street to Abney Avenue;

Beginning at the present Pavement on South First Street; thence South with said South First Street to J. H. Gibson's residence;

Beginning at the intersection of South First Street and Shepherd Avenue; thence East with said Shepherd Avenue to Kaiser Street;

Beginning at the present Pavement on Ellis Avenue where it intersects Cotton Square; thence West on said Ellis Avenue to its intersection with Raguet Street:

Beginning at the intersection of Ellis Avenue and Raguet Street;
Thence North on Said Raguet Street to Wiener Avenue; thence West on
said Weiner Street to First Street in the Angelina County Lumber Company
Addition to the town of Lufkin; thence with said First Street in Angelina County Addition North to the City Limit line;

Beginning at the intersection of Raguet Street and Ellis Avenue; thence South on said Raguet Street to its intersection with Jefferson Avenue;

Beginning at the intersection of Raguet Street and Frank Avenue;
Thence West on said Frank Avenue to Bynum Street;

thence East wn said Frank Avenue to Herndon Avenue;

thence East wn said Frank Avenue to Herndon Avenue;

said Lussin avenue to its interestion with fauth Street;
