

MINUTS OF REGULAR MEETING OF
THE CITY COMMISSION OF THE CITY OF LUFKIN,
TEXAS, HELD DECEMBER 6th, 1921.

Be it remembered that on this the 6th day of December, A.D. 1921, there was begun and holden a regular meeting of the City Commission of the City of Lufkin, Texas, at the Municipal Office thereof, in said City: Present and presiding the Hon. G. A. Kelley, Mayor, S. R. Parker, Commissioner of Ward No. 1, B. L. Zeagler, Commissioner of Ward No. 3 W. B. Treadwell, Commissioner of Ward No. 4, E. E. Woods, Commissioner of Ward No. 2 (being Absent), T. L. Dunn, Temporary City Manager and City Secretary, When ~~when~~ the following proceedings were had, to-wit:-

Minutes of former meetings of the City Commission read and by move and second duly made and carried were adopted.

A petition signed by practically all residents on North Reservation Street was presented to the City Commission praying that the name of said Street be changed to Magnolia Street. After due consideration and discussion of said petition, by move made by Commissioner S. R. Parker and Seconded by Commissioner W. B. Treadwell which said motion unanimously carried, it is ordered that the name of said street, to-wit North Reservation Street be changed to Magnolia Street.

An account of Dr. D. M. Childers for damages alleges to have been incurred by reason of his having hit one of the turn blocks in the streets was discussed by the Commission after which by move by S.R.Parker and seconded by B.L.Zeagler, it is ordered that said account be refused and not paid.

All accounts due by the City to various parties, firms and corporations were presented for payment, and it appearing that same had been duly audited and allowed by the City Manager, by move and second duly made and carried, same were ordered paid.


-----oOo-----
An application having been made for the improvement of a street to be opened up by Mr. Falvey through what is known as the S. Abram property, was given consideration, after which by move and second duly made and carried, it was ordered that same be graded and improved when same is properly surveyd out and dedicated to the City of Lufkin, Texas.

The question of constructing a sewer line through Mantooth street was deferred until some future time.

The question of electing a City Manager for the City of Lufkin, Texas, was gone into and after due consideration of said question, it was moved by Commissioner S. R. Parker and seconded by Commissioner E. E. Woods that C. N. Humason be elected and appointed to said position. Said Motion carried unanimously, and the said C.N.Humason declared elected.

There being no further business to come before the meeting, by move and second duly made and carried adjournment was taken.
