## MINUTES OF CALL MEETING OF THE CITY COMMISSION OF THE CITY OF LUFKIN TEXAS HELD AUGUST THE 24th. 1922.

Be it remembered on this the 24th. day of August A. D. 1922 there was begun and holden A Call Meeting of the City Commission of the City of Lufkin, Texas at the Municipal Office thereof: present and presiding the Hon. G. A. Kelley Mayor, S. R. Parker Com. #1 B. L. Zeagler Com. #2 E. E. Woods Comm. #2 and W. B. Treadwell Comm. #4 C. N. Humason City Manager, C. H. Rice City Secretary and W. O. Seale City Attorney when the following proceedings were had to wit:

Mayor G. A. Kelley stated that the purpose of the meeting was called for the purpose of submitting kin for passage the following ordinances: AN ORDINANCE AMENDING SECTION ONE OF ORDINANCE NUMBER EIGHTEEN ENTITLED: "AN ORDINANCE ESTABLISHING AND DEFINING THE FIRE LIMITS AND PROVIDING CHARACTER OF MATERIAL TO BE USED IN THE ERECTING, CONSTRUCTIONS REPAIRING, REMODELING OR REPAIRING BUILDINGS WITHIN SAID LIMITS; AND PROVIDING PENALTIES" PASSED AND APPROVED ON THE 23rd. DAY OF MAY A.D. 1914, AMENDED BY AN ORDINANCE PASSED AND APPROVED THE SECOND DAY OF MAY A.D. 1922, salso AN ORDINANCE GREATING THE EXTENSION OF DOZIER AVENUE WEST TO CONNECT WITH FRANK AVENUE, APPROVING CONDEMNATION PROCEDINGS OVER AND ACROSS THE PROPERTIES OF THE SAINT LOUIS SOUTHE WESTERN RAIL ROAD COMPANY OF TEXAS AND THE EASTERN TEXAS RAILROAD COMPANY FOR THE EXTENSION OF SAID AVENUE APPROPRIATING THE SUM OF \$250.00 OR SO MUCH THEREOF AS MAY BE NECESSARY FOR THE PAYMENY OF THE AMOUNT OF DAMAGES THAT MAY BE ASSESSED BY THE BOARD OF SPECIAL COMMISE SIONERS, AND DECLAREING AN EMERGENCY. after reading the above ordinances and discussing same mayraxiby move and second duly made all present voting AYE.

There being no futher business to come before the Commission, by move and second duly made and carried, adjournment was taken.
