E. L. Kurth of Keltys, Texas, appeared before the City Commission in the interest of the bringing to the City of Lufkin a Paper Mill, and wanted to know if the City of Lufkin would assist in paying the expense incident to prospecting for a sufficient water supply to operate such a paper mill should same be located in this City. His talk was listened to with interest, and he was promised that the question would be given carefuly thought and consideration and agreed to meet with the directors of the Chamber of Commerce at an early date to discuss further the same question. Mr Jno. S. Redditt appeared in behalf of the Lufkin Library organization and made the plea that they were short of funds to operate same since the opening of the publis schools, and asked the city to commission to begin at once the paying to the Lufkin Library the sum of \$50.00 per month instead of \$25.00 as being done at this time; he pointing out that such sum of \$50.00 per month was provided in the annual budgent of the City. After carefully considering the matter and it being shown that likely the library would be called upon more now than usual on account of the opening of the schoolds, it was moved by C.A. Burke and seconded by W.A. Abney that the amount being paid to the Lufkin Library be increased to \$50.00 per month, beginning with the first of September 1931 The motion carried unanimously.

An ordinance entitled "AN ORDINANCE ESTABLISHING A FIRE PREVENTION BOARD, PROVIDING FOR ITS MEMBERSHIP, ITS ORGANIZATION, PRESCRIBING ITS DUTIES AND OFFICE, AND DECLARING AN EMERGENCY", was introduced for passage and approval. The said ordinance having been read to the Gity Commission, it was moved by W. O. Greene, and seconed by C. A. Burke that said ordinance be passed and approved, and that the rules requiring ordinances to be read on **intram**-two several days before final passage and approval be suspended, and that said ordinance pass on first reading. The Mayor put the question and the following is the vote taken: "Ayes"- Wm. A. Foster, W. O. Greene, C. A. Burke, and W. A. Abney. "Noes"- None.
