Austin, in the amoun of \$307.50, which they claim is the balance of a fee due them for refunding Bonds of the City of Lufkin, Texas, The matter was carefully considered in the light of the Contract entered into between the said Harby, Lyon and King and C. W. Austin and the City of Lufkin, and it was the opinion of the City Commission that the City did not owe the fee claimed, hence on motion by J. B. Perry, seconded by Lewis Hicks, it was unanimously carried that payment of the amount be refused.

M. M. Jones was present and requested that his tractor and grader be placed in service at the WPA Air Port Project, the price to be paid \$250.00 per month, him to maintain the equipment at his own expense, but the City to furnish fuel and oil, also pay operators of same. He, the said M. M. Jones, stating that he desired the amount coming to him for the hire of the equipment to be applied on his City Taxes. After considering the matter it was moved by J. B.
