

MINUTES OF REGULAR MEETING OF THE CITY COMMISSION
OF THE CITY OF LUFKIN, TEXAS, HELD NOVEMBER 5th,
1957, at 7:30 P.. M.

On this the 5th day of November, A. D., 1957,
the City Commission of the City of Lufkin, Texas, convened in
regular session, in the regular meeting place in said

the following business was transacted:

1. The meeting was opened with a prayer by Commissioner W.C. Royle of Ward No. 2.
2. The Minutes of the Regular Meeting of October 17th, were read and approved.
3. Mr. J.F. Williamson, representing Southern Signals, Inc. of Shreveport, Louisiana, came before the Commission and demonstrated and explained in detail traffic signals for pedestrian and vehicular traffic on the proposed one-way streets.
4. The Commission, after discussing and considering the traffic signals as demonstrated by Mr. Williamson, agreed to advertise and call for bids on four signal lights to be used at four street intersections, and also for signal lights for eight street intersections.
5. The Commission passed on first reading the One-way Street Ordinance controlling and directing traffic on the following streets:

Angelina Street designated as a one-way street for north bound traffic movement only, between Burke Avenue and Bremond Avenue;

First Street designated as a one-way street for south bound traffic movement only, between Bremond Avenue and Burke Avenue;

Second Street designated as a one-way street for north bound traffic movement only, between Burke Avenue and Bremond Avenue;

Third Street designated as a one-way street for south bound traffic only, between Bremond Avenue and Burke Avenue;


One-way traffic movement around the Court House Square shall be clockwise. Traffic shall enter at the Southeast corner of the Court House Square and Third Street, and at the Northwest corner of the Court House Square and Second Street, and the exit of traffic around the Court House Square shall be at the Northeast corner of the Court House Square and Third Street, and the Southwest corner of the Court House Square and Second Street. All other street openings to the Court House Square shall be closed.

6. The Commission passed the Ammendment to Section 3 of the present Parking Meter Ordinance. Such Ammendment declares all streets and Avenues a Parking Meter Zone within the City of Lufkin, and said Ammendment was passed as an emergency measure, making it effective from and after publication, as provided by the Charter.
7. The City Manager was authorized to install parking meters on both sides of Second Street from Sheppard Avenue to Burke Avenue.
8. Upon the recommendation of the City Manager, the Commission authorized the investment of approximately \$50,000.00 now in the Water and Sewer System Revenue Bond Reserve Fund, in the Mercantile National Bank, Dallas, in Government Bonds.
9. The Commission passed the Resolution adding Veterans Day as one of the legal holidays to be observed by the City.
10. The Privy Ordinance was passed on Second and Final reading, and publication of same was ordered.
11. Publication of proposed zone change on certain property on Lufkin Avenue from "C" and "F" District to "H" District was ordered, such final hearing to be at the Regular Meeting to be held December 3, 1957.
12. The City Commission authorized payment of Estimate No. 2 on Chicago Bridge and Iron Company Elevated Water Storage Tank, contract in the sum of \$57,894.35.
13. It was agreed to extend parking courtesies to out of town guests to conventions held in Lufkin. Such parking courtesies would exclude local people.
14. There being no further business to come before the City Commission the meeting adjourned.
