Be it remembered that on this the 2nd day of February, A.D. 1932
that there was begun and holden a regular meeting of the City Commis-
sion of the City of Lufkin, Texas, in the City Hall in said City, with

when the following proceedings were had, to-wit:-

Minutes of former meetings read and on motion duly made and
carried were approved as read.

Mr. E. L. Kurth, one of the Administrators of the J.H. Kurth
Estate appeared before the City Commission and made it known that
his father, the late J. H. Kurth, had provided in his will for a
sum of money in the amount \$10,000.00 to be spent for establish-
ment or building of some kind of civic enterprise, and that they
had decided on the erection of a public library, and requested the
City Commission to donate as much as would be necessary of what is
known as Cotton Square as a site on which to build said library.
The Matter was considered after which it was moved by W.O. Greene,
and seconded by M. M. Jones, that such request be granted on condi-
tion that the City would be permitted to make such donation under
the terms of the original grant to the City, of Cotton Square, and
not loose title to same, and on the further considtion that in case
such site ever ceased to be used as a Public Library site, it would
revert back to the City. The motion having been put by the Mayor,
it carried unanimously.


An ordinance entitled "AN ORDINANCE RELEASING PENALTIES AND
INTEREST ON ALL CITY TAXES DELINQUENT UP TO MAY 31, 1932, PROVID-
ING SAID TAXES ARE PAID ON OR BEFORE MAY 31, 1932; DECLARING AN
EMERGENCY AND SUSPENDING ALL ORDINANCES AND PARTS OF ORDINANCES
IN CONFLICT HEREWITH" was presented by City Attorney R. C. Mussle-
white for consideration by the City Commission, and the same having
be read to the City Commission and discussed and considered, it was
moved by M. M. Jones and seconded by C. A. Burke that same placed

on first and final reading, and that same be passed and approved as an emergency measure. The Mayor put the question as required, and the following is the recorded vote on same, to-wit "AYES" Wm. A. Foster, W. O. Greene, C. A. Burke, M. M. Jones and W. A. Abney- "Noes"- None- Whereupon the Mayor declared the motion carried and the said ordinance finally passed and approved. An Ordinance entitled "AN ORDINANCE PROHIBITING IN THE CITY OF LUFKIN SOLICITING ORDERS FOR FUTURE DELIVERY OF GOODS, WARES, MERCHANDISE, SUBSCRIPTIONS TO MAGAZINES AND NEWSPAPERS AND ORDERS FOR PHOTOGRAPHS TO BE TAKEN IN THE FUTURE WITHOUT PERMIT FROM THE CITY MANAGER OF THE CITY OF LUFKIN, REQUIRING BOND FROM SOLICITORS ACCEPTING OR COLLECTING PAYMENT OR DEPOSIT IN ADVANCE OF FINAL DELIVERY, AND PRESCRIBING A PENALTY FOR THE VIOLATION OF SAME" was presented for passage and approval on second and final reading. W. A. Abney made a motion that said ordinance be placed on second reading and that same be finally passed which said motion was seconded by C. A. Burke. The Mayor put the question as required and the following is the recorded vote on same: "AYES"- Wm. A. Foster, W. O. Greene, C. A. Burke, M. M. Jones and W. A. Abney. "NOES"- None. Whereupon the Mayor declared the motion carried and the ordinance finally passed and approved(See another page of these minutes for said ordinance) 00
