MINUTES OF A CALL MEETING OF THE
CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS,
HELD DECEMBER 15th, 1938.

Be it remembered that on this the 15th day of December A. D. 1938, there was begun and holden a call meeting of the City Commission of the City of Lufkin, Texas, at the Municipal Office in said City, with the following officers of the City Present and presiding, to-wit:

The following proceedings were had, to-Wit:

Bread Men (Bakeries) and grocerymen, and other Citizens appeared and made known that outside competition was making it impossible for them to continue in business at the price they are forced to meet. Mr. Sherwood Spivey, from Chamber of Commerce spoke on behalf of the bakersmen, and J. L. Crawford also spoke in their behalf.

City Commission expressed itself as being in full sympathy with the idea of protecting Home Bakeries, and promised full Cooperation, and that any legal acts that would afford the protection asked for.

B. Rolston, County Judge, and Jack Nerren and Bud Hinson, County Commissioners appeared and requested that FREE water and sewer be allowed the Angelina County Hospital. Action deferred for further thought and consideration.

Mrs. Eva Sharpe and F. J. Stephenson, Real Estate Firm appeared and requested that Water & Sewer Mains be built in New Park View Addition to the City of Lufkin. Passed without definite action---other than to promise a 2" Water service as houses are built.

A motion was made by Lewis Hicks and seconded by J. B. Perry that Mayor W. M. Glenn be authorized to execute a Quit-Claim deed to Mrs. S. A. Beckcom for alley in A. P. Johnson Addition to the City of Lufkin. The Motion carried unanimously.

A Motion was made by Lewis Hicks and seconded by J. B. Perry that resolution be passed Ammending Wage Rate Ordinance. The Motion carried unanimously.
