MINUTES OF REGULAR MEETING OF THE
CITY COMMISSION OF THE CITY OF LUFKIN,
TEXAS, HELD APRIL 7th, 1936.

Be it remembered that on this the 7th day of April, A.D. 1936, there was begun and holden a regular meeting of the City Commission of the City of Lufkin, Texas, at the Municipal Office in said City with the following officers of the City present and presiding, to-wit:-

The following proceedings were had, to-wit:-

Minutes of all meetings held during the Month of March, A.D. 1936, were read and on motion duly made and carried were approved as read.

An ordinance entitled "AN ORDINANCE AMENDING SECTION TWO OF A CERTAIN ORDINANCE DEFINING THE FIRE LIMITS AND REGULATING THE CONSTRUCTION, ALTERATION, MAINTENANCE, REPAIR, AND REMOVAL OF BUILDINGS WITHIN THE CITY OF LUFKIN, AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF"

was introduced for passage and approval on first reading.

W. A. Abney made a motion that said ordinance be placed on first reading and that it pass first reading. The motion was seconded by Lewis Hicks. The Mayor put the question on the motion and the following is the recorded vote on the motion: "AYES"- Kenneth Hoskins, Lewis Hicks, ~~W. O. Greene~~ and W. A. Abney. "NOES"- None. Whereupon the Mayor declared the motion carried and the said ordinance passed and approved on first reading.
