

MINUTES OF SPECIAL MEETING OF THE CITY COMMISSION OF
THE CITY OF LUFKIN, TEXAS HELD JUNE 9, 1953 AT
7:30 P. M.

On this the 9th of June A.D. 1953, the City Commission of the City of Lufkin, Texas convened in Special Session at the Regular Meeting place in said City with the following members thereof present:

The minutes of the Regular Meeting held June 2, 1953 at 7:30 P.M. were read and approved by the Commission.

1 The Council received and approved for publication the following Zone Change applications:

1. First Christian Church to change the zone from "A" District to "B" District on a 6 acre tract of land owned by it and being portions of that tract of land conveyed by W. G. and C. F. Thompson to Earnest Finley by deed of record in Book 10, page 319, Deed Records of Angelina County, Texas, and a portion of a 2 1/6 acre tract which was conveyed by L. Finley and wife to Ella Cloyd by deed of record in Book 26, Page 132, Deed Records of Angelina County, Texas.

2. Willie Brown and wife, Geneva Brown, for change of zone from "A" District to "F" District on lot 77 feet by 77 feet located on Booker Street and on the North side of Kurth Drive in the City of Lufkin, Texas.

3. W. A. Kirkland to change the zone from "A" District to "F" District on tract of land designated on the City Map as tract number 12, map number 16, said tract of land being on the East side of South First Street, 1501 South First Street, City of Lufkin, Texas.


4. A. Stroud Estate to change from "A" District to "H" District the zoning designation on blocks numbers 4 and 5 of the Fairchild-Boynton Addition to the City of Lufkin, Texas, save and except the portion of said blocks heretofore conveyed to the State Highway Department.

5. The Council passed on first and second reading an Ordinance regulating the admission of new additions to the City of Lufkin, requiring new additions be supplied with water and sewer facilities and all weather streets of some type to be approved by City Planning Board or the City Commission. First Reading - Motion - Collins - Second - Brittain, all voting "Aye". Second Reading - Motion - Gipson - Second - Collins, all voting "Aye".

6. On motion of Commissioner Gipson, seconded by Commissioner Collins, all voting "Aye" the Commission agreed to furnish three trucks and nine men for the clean up drive, and also an additional sum not to exceed \$150.00 for additional labor.

7. The Council adopted as policy to set garbage collection charge of 2/3 of number of units, when an owner has 12 or more units.

There being no further business, the meeting duly adjourned.
