## Lufkin, Texas, April 10th., 1915.

Be it remembered that on this the 10th. day of April A. D. 1915, there came on and was held an adjourned session of the City Gouncil of the City pf Lufkin, Texas, pursuant to adjournment by this body on yesterday afternoon and night, April 9th., 1915. There were present and acting at this meeting the following members of the City Gouncil; C. N. Humason, Mayor, L. H. Gray, City Secretary, B. F.Gibson, Alderman, T. A. Taylor, Alderman, S. H. Kerr, alderman. Alderman Fairchild being absent.

The following proceedings were had to-wit;

Mr. G. T. Cross, representing the Progressive League, appeared before the Council, praying that this City fulfil its contract or agreement, wherein they promised to provide fire fighting equipment Exxix at the P. A. Ryan Lumber Co. Mill, by installing fire hydrants, either one or two at its mill on the right of way line of the St. L. S. W. Ry., and connecting the City's mains with those of the St. L. S. W. Ry.

A Motion was made by alderman Kerr, duly seconded by alderman Gibson, all aldermen voting aye, that this Council order this work done, and after an investigation of the Cost of same, and plans submitted by the water commissioner, which had been approved by Mr. Callahan of the St. L. S. W. Ry. Co, showing the probable cost of make to be \$150.00, an amount was appropriated out of the water works improvement fund and the water commissioner Gray instructed to make this connection, at a cost not to exceed the above amount.

Motion by alderman Taylor, seconded by alderman Kerr, all aldermen voting aye, that the City Engineer be instrcted to prepare specifications on a water line extending from this City's mains down Gemetery or Glendale avenue to a point to connect with the mains of the L. L. & L. Co., get prices on same, prepare an ordinance covering same, and to submit same to the next meeting of this City Council.

Report of E. E. Gochran City Treasurer submitted for inspection and approval, but as it seemed incomplete, it was referred to him and the Auditing committee.

Report of G. A. Medford Assessor and Collector submitted for inspection and approval, which was referred to the auditing committee.

Minutes of meetings March 2nd, 5th., 10th., 22nd., read and approved.

Minutes of meetings April 6th., 8th., 9th., read and approved.

Motion by alderman Kerr, Seconded by alderman Taylor, all aldermen voting aye, that and ordinance be passed and approved, styled "AN ORDINANCE TO ASSESS A PART OF THE GOST FOR IMPROVING ANGELINA AVENUE FROM THE NORTHERLY PROPERTY LINE OF DOZIER AVENUE TO THE NORTHERLY CURB LINE OF SHEPHERD AVENUE EXCEPT DEPOT SITE AND SURROUNDINGS: AND FIRST STREET BETWEED THE NORTHERLY RIGHT OF WAY XX LINE OF THE ST L. S W RY COMPANY OF TEXAS TO THE NORTHERLY CURB LINE OF SHEPHERD AVENUE" and the same is hereby passed and approved.

Motion by alderem Kerr, seconded by alderman Gibson, all aldermen voting aye, that an ordinance be passed and approved, styled "AN ORDINANCE TO ASSESS A PART OF THE COST FOR IMPROVING THAT PART OF FIREMANS PARK FRONTING LOTS THIRTEEN TO EIGHTEEN INCLUSIVE IN BLOCK THREE WITH THE BITULITHIC PAVEMENT AGAINST THE OWNERS OF PROPERTY ABUTTING UPON SAID STREET WITHIN SAID LIMITS AND AGAINST THEIR PROPERTY AND PROVIDING FOR THE ENFORCEMENT AND COLLECTION THEREOF. AND DEGLARING AN EMERGENCY", and the same is hereby passed and approved.

Motion by alderman Gibson and seconded by alderman Taylor, all aldermen voting aye, that an ordinance be passed and approved, styled, "AN ORDINANCE TO ASSESS A PART OF THE COST FOR IMPROVING LUFKIN AVENUE BETWEEN FIREMAN'S PARK AND THE EASTERLY LINE OF SECOND STREET; EXCLUDING THE INTERSECTION OF FIRST STREET, AND DOZIER AVENUE BETWEEN ANGELINA AND FIRST STREET INCLUDING THE INTERSECTION OF COTTON STREET; WITH THE BITULITHIC PAVENENT, AGAINST THE OWNERS OF PROPERTY ABUTTING UPON SAID STREET WITHIN SAID LIMITS, AND AGAINST THEIR PROPERTY AND PROVIDING FOR THE ENFORCEMENT AND COLLECTION THEREOF AND DECLARING AN EMERGENCY, and the same is hereby passed and approved.
