The purpose of the meeting was stated by the Mayor to be to discuss and pass on first reading certain ordinances of the City, and to do and perform any other business that might properly come before the meeting.

An ordinance entitled "AN ORDINANCE PROHIBITING SPIELING, YELLING, LOUD TALKING, LOUD SPEAKING DEVICES, AND ADVERTISING OF SHOWS, CIRCUSES AND OTHER ATTRACTIONS, AND PROVIDING A PENALTY THEREFOR" was introduced for passage and approval on first reading.

W. O. Greene made a motion that said ordinance be placed on first reading and that it pass first reading. Louis Hicks seconded the motion. The following is the recorded vote on the motion, towwit: "AYES"-Kenneth Hoskins, W. O. Greene, Louis Hicks and W.A.Abney. "NOES"- None. Whereupon the Mayor declared the motion carried and the ordinance passed and approved on first reading.

An ordinance entitled "AN ORDINANCE AMENDING SECTION 1 OF AN ORDINANCE REGULATING VEHICULAR AND PEDESTRIAN TRAFFIC IN THE CITY OF LUFKIN IN THE TERRITORY COVERED BY THE BLOCK SIGNAL SYSTEM WHICH ORIGINAL ORDINANCE WAS PASSED BY THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS, ON THE FIRST DAY OF OCTOBER A.D. 1929, SO AS TO PERMIT A RIGHT HAND TURN UPON A RED LIGHT, PROVIDED THE AUTOMOBILE OR OTHER VEHICLE COMES TO A COMPLETE STOP BEFORE TURNING TO THE RIGHT"
