Woods, Jr. from \$185.00 to \$200.00, G. E. Alderman from \$185.00 to \$200.00, Woodrow Hoover from \$180.00 to \$190.00, Jack Fuller from \$180.00 to \$190.00, Batson Treadway from \$185.00 to \$190.00 and H. M. Thrailkill from \$175.00 to \$190.00, to become effective September 15th.
- 6. Mr. McClendon, was instructed to contact Mr. Howard Walker, City of Lufkin's Right-of-Way Agent, to prepare an estimate on the Eli Bynum and J. H. Purvis tracts, that are affected by the tentative location of the extention of Frank Avenue West.

There being no further business motion was made by Zeagler and seconded by Treadwell to adjourn.
