

MINUTES OF Regular MEETING OF THE CITY COMMISSION
OF THE CITY OF LUFKIN, TEXAS, HELD July 20th
1950 AT 1:15 P.M.

On this the 20th day of July, A.D. 1950,
the City Commission of the City of Lufkin, Texas, convened in
regular session, in the regular meeting place in said
City, with the following members thereof, to-wit:

being present, and the following absent: R. A. Courtney,

constituting a quorum when the following business was transacted:

1. Mr. Curtis Fenley, along with several other members of the First Baptist Church met with the Council in regard to getting a building permit for educational building on Bremond. Mr. C. E. Brazil, City Attorney, advised the Council that no building permit could be issued under present Zone Classification, but that the Council could pass a special ordinance, putting all churches in Zone H, and a building permit could be issued. However, if the church was ever abandoned and sold for other use than a church, it would automatically fall back into its original classification. Motion was made by L. B. Zeagler and seconded by J. M. Snell, to class all churches in Zone H. All voted "aye". Approved on Second reading, motion made by Joe Stegall and seconded by L. B. Zeagler, all voted "aye".

2. Mr. B. L. Curry and Troy Irwin, with the Lufkin Transit Company, met with the Council to present new franchise for ten years with raise in bus fare. Council advised them they would have to study new franchise and raise in bus fare before passing on same. But would pass on it at their next regular meeting August 17th.

3. Mrs. Viesca Powell met with Council in regard to water rates. She was advised by the Council that she was paying in accordance with new rates like all other consumers.

4. Mr. J. M. Snell brought up the question of trying concessions out at Old City Park, believed there might be some additional revenue. Council advised Mr. McClendon to try to work something out on same.

5. Mr. L. B. Zeagler suggests that something must be done to remove cars off city streets at night in order for sweeper to properly clean streets, especially around Angelina Hotel. Council advised Mr. McClendon to work something out with the Chief of Police.

6. Mrs. Simon Henderson ask Mr. McClendon to bring the question up to the Council on extending garbage service to people outside City Limits, providing they could have dumping points. Council opposed same, due to expense involved and would create a bad condition.

7. Mr. Arthur Temple wanted to know if the Council would permit him to lay his own water and sewer lines to property outside City Limits on Highway # 94 and tie into City Limits, in order to get city utilities to his property. No action taken.

9. Mr. C. E. Brazil, City Attorney, passed out copies of an instrument he drew up on proposal to furnish City water to users outside city limits. Council wanted time to study same before any action on same.

9. Ordinance on Plumbers equalizing passed out to council for study.

10 Discussion of hiring new City Manager brought up. Mr. Harry Steenson from Mt. Pleasant discussed, but no action taken.

" Bills on motorcycles brought up, due to increase of price since order was given, but council ruled to let price stand as quoted.

12 Warrants discussed.

There being no further business motion was made by Joe Stegall and seconded by J. M. Snell to adjourn.
