

MINUTES OF A REGULAR MEETING OF THE
CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS,
HELD DECEMBER 4th. 1928.

Be it remembered that on this the 4th day of December, A.D. 1928,
there was begun and holden a regular meeting of the City Commission of
the City of Lufkin, Texas, at the Municipal Office thereof in said City;
Present and presiding the following officers of the City, to-wit: J.W.
Hawkins, Mayor, C. A. Burke, Commissioner of Ward No. 2, M. C. Spivey,
Commissioner of Ward No. 3, W. A. Abney, Commissioner of Ward No. 4,
V. R. Smitham, City Manager, and O. Seaden, City Attorney and T. L. Dunn,
City Secretary, (Joe C. Denman, Commissioner of Ward No. 1 being ab-
sent), when the following proceedings were had, to-wit:-

Minutes of former meetings except the one of date November 20th,
were read and approved on motion duly made and carried. The Minute of
the November 20th meeting was passed for correction.

It appearing that the necessary bonds in connection with the
contract for the construction of an Incinerator had been filed and
that same were satisfactory, on motion made by C.A.Burke and seconded
by M. C. Spivey said contract was submitted for final approval by
ordinance on second reading. The Mayor put the question and the fol-
lowing vote is entered hereon: "Ayes"- J.W.Hawkins, C.A.Burke, M.C.
Spivey and W.A.Abney. "Noes" - None+ Whereupon the Mayor declared
the motion carried and the contract hereby approved by ordinance on
second reading.

On motion made by W.A.Abney seconded by M.C.Spivey an ordinance
was passed approving Engineer's letter correcting paving assessments on
the following streets, to-wit:-Frank Avenue from its intersection with
the West line of North Raguet Street to its intersection with the east
line of Bynum Street; Mantooth Avenue from its intersection with west
line of North Raguet Street to its intersection with the East line of
Bynum Street; Cain Street from its intersection with south line of Abney
Avenue to its intersection with north line of Bremond Avenue; South
Second Street from its intersection with south line of Shepherd Avenue
to its intersection with north line of Denman Avenue; from Shepherd
Avenue to Townsend Avenue; Herndon Street from its intersection with
north line of Ellis Avenue to its intersection with north line of
Mantooth Avenue; South Raguet Street from its intersection with south

line of Kerr Avenue to its intersection with north line of House Avenue; Paul Avenue from its intersection with east line of Second Street to its intersection with west line of Third Street; Lufkin Avenue from its intersection with west line of Third Street to its intersection with east line of Fourth Street; North Second Street from its intersection with north line of Paul Avenue to its intersection with north line of Rhodes Avenue; Thompson Street from its intersection with south line of west Grove Avenue to its intersection with north line of Mantooth Avenue; West Grove Avenue from its intersection with west line of North Raguet Street to its intersection with west line of Thompson Street; South Raguet Street from its intersection with south line of Ellis Avenue to its intersection with south line of Jefferson Avenue; Jefferson Avenue from its intersection with west line of South Raguet Street to its intersection with S.E. corner of A.E. Percy's property, same being S.W. corner of Lot 4 Block 2 Hill Addition; Groesbeck Avenue from its intersection with east line of North First Street to its intersection with west line of Chesnut Street; Montrose Street from its intersection with North line of Shepherd Avenue to south line of Jodie street. Said motion carried by the following vote, to-wit: "Ayes" J.W. Hawkins, C.A. Burke, M.C. Spivey and W.A. Abney. "Noes"- None. The Mayor declared the motion carried and said ordinance passed, which said ordinance appears at another page in these minutes.

The City Manager having filed a letter reporting the completion according to contract by Mr Scott Shambaugh, paving contractor, of the following streets or alleys: Culverhouse Street from its intersection with east line of North Angelina Avenue to its intersection with south line of Abney Avenue; West Grove Avenue from its intersection with east line of North Raguet Street to its intersection with west line of North Bonner Street and Burke Avenue from its intersection with east line of First Street to its intersection with north line of Charlton Street, it was moved by M. C. Spivey and seconded by C. A. Burke that said pavement on said streets be accepted as final. Said motion carried unanimously.

It having been made known to this City Commission that recently at a session of the East Texas Firemen's Association held at Huntsville, the drill team of the Volunteer Fire Department of the City of Lufkin, won the loving cup in a contest held with other cities of the District, and the question of in some way expressing or showing the appreciation held by the City Commission for

said drill team was discussed. It was suggested by Chief Harry Kerr of the Lufkin Fire Department that sweaters with proper lettering be presented to said team. It was moved by C.A.Burke and seconded by M.C. Spivey that 13 sweat~~ers~~ be bought and one each presented to each member of the drill team as aforesaid as a token of appreciation for having won the loving cup as aforesaid. The Motion carried unanimously, and Chief Kerr and City Manager V.R.Smitham were instructed to make selection of the sweaters.

MINUTES OF REGULAR MEETING OF THE CITY COMMISSION OF THE CITY OF LUFKIN HELD DECEMBER 4th, A. D. 1928.

BE IT REMEMBERED that on this the 4th day of December A. D. 1928, there was begun and holden a regular monthly meeting of the City Commission of the City of Lufkin, Texas, at the Municipal Hall thereof with the following members present, to-wit: Dr. J. W. Hawkins, Mayor; C. A. Burke, Commissioner Ward No.2; M. C. Spivey, Commissioner Ward No.3; W. A. Abney, Commissioner Ward No.4; V. R. Smitham, City Manager, T. L. Dunn, City Secretary, and W. O. Seale, Attorney, when the following proceedings were had, to-wit:

It appearing to the City Commission that the following streets and avenues, viz:

(a) Culverhouse Street from its intersection with east line of North Angelina Avenue to its intersection with south line of Abney Avenue;

(b) West Grove Avenue from its intersection with east line of North Raguet Street to its intersection with west line of North Benner Street;

(c) Burke Avenue from its intersection with eastline of First Street to its intersection with north line of Charlton Street; have been completed according to contract for street paving with Scott Shambaugh of Houston, Texas, of date Aug. 24th, A. D. 1928, and the acceptance of said three streets and avenues having been recommended in writing by the City Engineer and City Manager, Mr. V. R. Smitham; on motion M. C. Spivey seconded by C. A. Burke, all voting yea, said three streets and avenues were accepted from Scott Shambaugh, paving contractor, and said street improvement on said three streets and avenues is now received and accepted by the City.

The Mayor and City Secretary are hereby authorized and directed to issue improvement assessment certificates therefor in accordance with the assessments ordinance heretofore passed, a form of said assessment certificate being attached hereto, marked "Exhibit A" and made a part hereof, which form is in all respects approved.
