on motion C.A. Burke, seconded by M.C. Spivey, all voting "yea" it was moved and carried that the City of Lufkin grant to L.F. Troxell a new gas franchise for a period of five years at the same rates as efferred by the Dixie Gas & Fael Co., and on condition that the said L.F. Troxell on or before Oct. 16th, A.D. 1928, would make, execute and deliver to the City of Lufkin, Texas, a good and solvent bond in the sum of \$25,000.00 guaranteeing the furnishing the city of Lufkin and its inhabitants gas in sufficient quantities within thirty days.

The following Streets were accepted as having been paved according to contract, viz: South Raguet St. from alis Ave to Jefferson Ave., and Jefferson Ave. from South Raguet Street to the East line of Mrs. A.E.Percy's property.

There being no further business to come before the meeting, of motion duly made and carried, same adjourned.

D. 1928, and the acceptance of said street and avenue have been recommended in writing by City Engineer and City Manager, Mr. W. R. Smitham; on motion W. A. Abney, seconded by C. A. Burke, all voting yea, said street and avenue were accepted from Scott Shambaugh, paving contractor, and said improvement on said street and avenue is now received and accepted by the City.

The Mayer and City Secretary are hereby authorized and directed to issue improvement assessment certificates therefor in accordance with the assessments ordinance heretofore passed, a form of said assessment certificates being attached hereto, marked "Exhibit A" and made a part hereof, which form is in all respects approved.
