MINUTES OF THE CITY COUNCIL, OF THE CITY OF LUFKIN, TEXAS.

Be it remembered that on this 6th day of April, A. D. 1915, there came on and was held a regular meeting the Lity Council of the City of Lufkin, Texas, in the Council Chambers of said city, there being present and presiding the following officers: C. N. Humason, Mayor, L. H. Gray, City Secretary, T. A. Taylor, Alderman, B. F. Gibson, Alderman, S. H. Kerr, Alderman I. D. Fairchild, Alderman, when the following proceedings, among others, were had, to-wit:

Moved by Alderman Gibson, seconded by Alderman Taylor, that an ordinance be passed approving a certain contract or agreement made and entered into on the 18th day of February A. D. 1915, by and between the City of Lufkin, as party of the first part, and P. A. McCarthy & Sons a Co-partnership as party of the second part, wherein, the City of Lufkin employs the said P. A. McCarthy & Sons to act and serve as Municipal and Consulting Engineers for the City of Lufkin, Texas, and appropriating money for the purpose of defraying the expenses to the payment of the services proposed to be rendered in persuance of the terms of said contract. The Mayor put the motion, tand the vote on this action stood as follows: Ayes, Aldermen, Kerr, Fairchilds, Taylor and Gibson. There were no votes cast against the proposition. The Mayor declared the motion carried, and the said ordinance is hereby past and approved.

Motion made by Alderman Kerr, seconded by Alderman Taylor, that an Ordinance be passed and approved, approving a contract made and entered into, on the 25th day of March A. D. 1915, by and between the City of Lufkin, as party of the first part, and C. M. McConnico of the same City, as party of the second part. Wherein, the said C. M. McConnico agrees, that the City of Lufkin, employs him to grade, gravel, and to grade, drag and dress up certain streets of the City of Lufkin, and appropriating money for the purpose of defraying the cost of said improvement, under the terms of said contract. The Mayor put the motion and the vote of this question stood as follows; Ayes Aldermen Kerr, Taylor, Gibson, and Fairchild. There were no votes cast against this, proposition. The Mayor declared the motion carried, and the office.

Motion made by Alderman Gibson, seconded by Alderman Fairchild, that the Mayor and City Secretary be empowered by authority to issue a Registered Town Warrant of any progress report or estimate on the above construction work presented them, approved by the City Engineer, The Mayor put the motion, all aldermen voting Aye and the Mayor declared the motion carried.

There being no further business, a motion was carried for this Council to meet in adjourned session, Thursday Night, April 8th, 1915.
