

MINUTES OF A CALLED MEETING OF THE CITY COMMISSION
OF THE CITY OF LUFKIN, TEXAS HELD ON MARCH 17, 1947
AT 7:30 P. M.

On this, the seventeenth day of March, 1947, A. D., the City Commission of the City of Lufkin, met in a called meeting in the regular meeting place in the said City with the following members, thereof, towit:

being present, with none absent, thus constituting a quorum, when the following business was transacted:

1. Mr. Ike Cox, Jr. was present to discuss the proposed extention of the city limits. He stated that he would like to get some information as to what service the newly annexed area could expect from the City. He was told that the area would be governed the same as that of the present city and as time and finances permitted all services would be extended to the area.
2. Mr. H. J. Shands was present and made a report on the petitions being circulated in the interest of extending the city limits. He stated that an accurate estimate of the number of qualified voters residing in the area had not been made and that it was thought that it would be better to withhold the petitions as incomplete until another check of the population could be made.
3. An application to change the zone of a portion of the South Montrose Addition from district "A" to district "C" and applied for by Arthur Temple Jr. was read on second reading. Public hearing on this application had been advertised for this meeting and as there was no opposition to the change it was moved by D. M. Thrash and second by B. F. Milligan that the zone change be allowed. The motion carried by unanimous vote of yea.
4. Mr. F. J. Melton chariman of the zoning board reported that it was his opinion that the Knights radiator shop on South Raguet Street was operating out of zone. He was told that an investigation of thematter would be made.
5. It was pointed out by Mr. Early that there had been a request from the Red Cross for a restricted parking area. The matter was discussed and it was decided not to allow the parking space.
6. The matter of paying time and one-half for overtime to laborers was discussed, after which, it was moved by B. F. Milligan and second by L. C. Martin to pay time and one-half to all labor after April 1, 1947 for overtime. The motion carried by unanimous vote of yea.
7. It was then moved by L. C. Martin and second by D. M. Thrash to charge 25¢ for children and 40¢ for adults for swimming in the new municipal pool--tax included. The motion carried by unanimous vote of yea.
8. Other matters discussed was the extention of parking meters on South First Street and the purchase of fertilizer for the airport. It was decided to extend the parking meters to Burke Ave. on the East side of South First and Mr. Early was authorized to purchase two tons of fertilizer for the airport.

No further business was presented, so the meeting adjourned.
