

Lufkin, Texas. February 20th., 1915.

Be it remembered that on thid the 20th., day of Feb. A.D. 1915, there came on and was held a ~~session~~ "SPECIAL CALL" session of the City Council of the City of Lufkin, in the Council chambers of said City, there being present and presiding the following officers:

When the following proseedings among others were had to-wit:

The purpose of the meeting as explained by the Mayor being to pass certain ordinances respecting the paving district, establishing a paving district, and attent to such other business as may properly come before the Council.

Motion by alderman Fairchild, second by alderman Taylor, all aldermen voting Aye that the Mayor, Secretary, and the City attorney arrange certain registered town warrants, ^{heretofore issued on the street alleys} making the proper ^{fund which was absorbed by the city} change in the records, ^{same} so that the holders thereof could realize ^{the same} their money on same from out of the Street and alley ^{fund} funds of the City of Lufkin.

Motion made by alderman Kerr, seconded by alderman Taylor, that an ordinance, " styled, "

AN ORDINANCE AUTHORIZING THE CONSTRUCTION OF PERMANENT STREET IMPROVEMENTSWITHIN THE CITY OF LUFKIN, TEXAS, AND PROVIDING RULES AND REGULATIONS WITH REFERENCE THERETO" be passed and ~~adopt~~ adopted. The vote on this question stood as follows: "AYES" Kerr, Taylor, and Gibson. Noes, alderman Fairchild. Alderman Fairchild stating his reason for voting against said ordinance being the reading of that portion of same, wherein it reads as follows: " The City Council shall have the right to accept any bid deemed most advantageous and beneficial to the City, and shall have the right to reject any and all bids"

The Mayor declared the ordinance passed and adopted.

Motion by alderman Fairchild, seconded by alderman Gibson, that an ordinance, styled, " AN ORDINANCE AUTHORIZING AND DESIGNATING IMPROVEMENT DISTRICT WITHIN AND FOR THE CITY OF LUFKIN, TEXAS, AND PROVIDING FOR THE PAVING OF STREETS AND MAKING CERTAIN REGULATIONS NECESSARY TO THE PROPER ENFORCEMENT AND CONDUCT OF SAID IMPROVEMENT" be passed and adopted.

The vote on this question stood as follows: "AYES" aldermen Gibson, Taylor, Fairchild and Kerr. "NOES" None.

Motion carried that Mayor Humason aldermen Kerr & Taylor be empowered with authority to lease deal or contract with Parke County for engineering services and fees respecting construction work now being carried on by the city of Lufkin and that this authority be in contemplation
