

REGULAR MEETING.
OF THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS,
HELD MAY 4th, 1920.

Be it remembered that on this the 4th day of May A. D. 1920, there was begun and holden a regular meeting of the City Commission of the City of Lufkin, Texas, at the Municipal Office thereof in said City of Lufkin Texas: Present and presiding the Hon. G. A. Kelley, Mayor, S. R. Parker, Commissioner Ward No. 1, E. E. Woods, Commissioner Ward No. 2, B. L. Zeagler, Commissioner Ward No. 3 and W. B. Treadwell, Commissioner Ward No. 4, and L. Mitchell, City Manager and T. L. Dunn, City Secretary, when the following proceedings were had, to-wit:-

City Manager L. Mitchell, made a report as follows:- That to grant the petition of Jno. L. Reece et als for the establishment of two proposed streets as set forth in said petition, and establish said streets, would cost the City for right-of-way etc. approximately the sum of \$1,000. Said report having been considered by the Commission, E. E. Woods made a motion as follows:-"To notify said petitioners that said streets would be granted and established on condition that right-of-way for the entire streets would be deeded to the City by General Warranty Deed". Said motion was seconded by S. R. Parker. The mayor put the question, and the following members of said commission voted "Aye"-S.R.Parker, E.E.Woods, B.L.Zeagler and W. B. Treadwell. The following voted "No"- None.- The Mayor declared said motion carried and same adopted.

The question of the collection of delinquent taxes due the city was discussed by the City Commission, after which E. E. Woods made a motion that the City Attorney be instructed and required to at once proceed according to law by bringing suit for collection of such delinquent taxes. Said motion was seconded by B. L. Zeagler. The mayor put the question, and same unanimously carried, and the Mayor declared said motion adopted.

The proposition of opening up a street, beginning at the east end of Lufkin Avenue; thence on a direct line to intersection with what is known as Glendale Cemetery Road, was considered by the Commission, after which E. E. Woods made a motion that said street be granted and opened up on condition that the property owners owning property over which said street would be, deed such property as would be occupied by said street to the City by General Warranty Deed. Said motion was seconded by S. R.

Parker. The question was then put before the Commission by the Mayor, and each and all of said Commissioners voted "Aye". The Mayor then declared the motion carried, and adopted.

The question of an extension of the sewer line on South First Street was discussed by the Commission after which E. E. Woods made a motion as follows: "That said extension be made on condition that as many as twelve (12) connection will be made on said extension". Said motion was seconded by B. L. Zeagler. The Mayor then put the question, and each and all of the Commissioners voted "Aye". The Mayor declared said motion carried and adopted.

All accounts and bills due by the city to various parties, firms and corporations was presented for payments, and it appearing that all of said bills had properly audited by the City Manager, by move and second duly made and carried, payment of same was authorized, and the city Secretary directed to write City Script in payment of same.

There being no further business to come before the meeting, by move and second duly made and carried, adjournment was taken.
