Mitchell, City Manager, and T. L. Dunn, City Secretary, when the following proceedings were had, to-wit:-

The Hon. Mayor and City Commission, Lufkin, Texas. Gentlemen:-

For \$100,000. Street Bonds of the City of Lufkin, maturing thirty years from date with option of redemption twenty years after date, and for \$50,000 Sewer Bonds of your City which bonds are a direct and general obligation of the entire City, maturing twenty years after date with option of redemption twn years from date, all bonds in denomination of \$1,000 each, dated January 1, 1920, bearing interest at the rate of 5½% per annum, payable semi-annually January 1st and July 1st of each year, both principal and interest to be payable at the Seaboard National Bank, New York, N.Y. or at the First National Bank, Chicago, Ill., at the option of the holder, we will pay you for same delivered to us in Chicago -

Complying with the terms of your advertisement, we are enclosing herewith, as evidence of our good faith, Cashier's check in the sum of \$1000 to be held by you pending the fulfillment of our contract. Should our attorney refuse to approve the legality of the issues, said check is to be returned to us at once.
