On motion of S.W. Hawthorne the following ordinance was presented his motion being to pass and approve same which was seconded by Chas. L. Bonner, after which the motion was put before the Council, and the following members of said Council voted to adopt said ordinance by voting "Aye". W.D. Price, S. W. Hawthorne, Chas. L. Bonner and T.A. Behannon. Alderman W.D. Newsom being absent and not voting.

The following members of said Council voted "No.". None.

AN ORDINANCE DECLARING THE RESULT OF AN ELECTION OF THE QUALIFIED VOTERS OF THE CITY OF LUFKIN, TEXAS, HELD ON THE 10th DAY OF MARCH A. D. 1919, ADOPTING THE SPECIAL CHARTER FOR THE CITY OF LUFKIN, TEXAS AS PREPARED BY THE CHARTER COMMITTEE HERETOFORE ELECTED TO FRAME SAME IN ACCORDANCE WITH THE PROVISIONS OF CHAPTER 147 OF THE GENERAL LAWS OF THE STATE OF TEXAS, PASSED BY THE 33rd LEGISLATURE AT ITS REGULAR SESSION, BEING TITLE 22, CHAPTER 17, ARTICLES 1096a TO 1096i, BOTH INCLUSIVE OF VERNON'S SAYLES' TEXAS CIVIL STATUTES 1914.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LUFKIN, TEXAS,
That whereas heretofore, to-wit: on the 10th day of March, A.D. 1919
an election was held by the qualified voters of the City of Lufkin,
Texas for the purpose of determining whether or not the said quali-
fied voters of said City should adopt the special charter prepared
by the charter committee elected on July the 15th, 1918 by the qual-
ified voters of said city in accordance with Chapter 147 of the Gen-
eral Laws of the 33rd, Legislature at its regular session and being
Title 22, Chapter 17, Articles 1096a to 1096i, both inclusive
of VERNON'S SAYLES', Texas Civil Statutes 1914, the said charter
being as follows:
