 ing business was transacted:
- 1. The meeting was opened with prayer by Mayor Woodrow W. Scott.
- 2. The minutes of the regular meeting held on January 17, 1956, were read and approved.
- 3. Mr. L. R. James from the local Social Security office appeared before the City Commission and gave a comprehensive discussion of Social Security for employees of the City. It was agreed that the heads of the various departments would canvass the employees to see if they desire social security, and if they did, then the City Commission would institute such steps as necessary to provide social security for its employees.
- 4. The City Commission voted to renew a street lighting contract with Texas Power and Light Company for a period of ten years from +46 C 112
- 5. It was agreed to advertise the sale of \$635,000.00 in bonds for March 20, 1956.
- 6. The Commission agreed to advertise for sale a triangular strip of land approximately 57 feet x 70 feet by 90 feet on Lufkin Avenue, such bids to be received and opened at its next meeting.

- 7. A zone change was granted Ben Vaughn on Lot No. 2, in Block #8, of the Denman Addition from "C" District to "H" District. Also zone change was granted Charlie M. Strahan on Lot No. 7 of the Re-Subdivision of Block #26 of the Amended Plat of the Lufkin Land and Lumber Company, Second Subdivision, from "A" and "F" District to "H", "J" and "K" District.
- 8. Street markers were discussed and it was agreed by the Commission that such program would be initiated and that such markers would be installed and completed over a a period of four (4) years.
- 9. A resolution was received and read from the Negro Chamber of Commerce, expressing their appreciation to the City Commission for the services the City of Lufkin has rendered and extended to the Negro sections of the City. Also they made certain recommendations and suggested further improvements respecting the Jones Lake Property.
- 10. An ordinance was passed calling for the general city election to be held on April 3, 1956, for the purpose of electing a Commissioner from Ward No. 2 and a Commissioner from Ward No. 4 of the City.
- 11. The City Manager was authorized to advertise for bids for a car to be used by the Fire Chief and Fire Marshall.
- 12. Water and sewer charges for churches and schools were discussed and it was agreed that the minimum sewer charge would be \$1.00 and one-half of the usual commercial rate for all installations above the minimum. Such rates to be effective April 1, 1956.

13. There being no further business to come before the Commission, the meeting adjourned.
