

MINUTES OF A CALLED MEETING OF THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS, HELD ON JANUARY 21, 1947 AT 3:30 P. M.

On this, the twenty-first day of January, A. D., 1947, the City Commission of the City of Lufkin, Texas, convened in a called session in the regular meeting place in said City, with the following members thereof, to-wit:

being present, with none absent, thus constituting a quorum when the following business was transacted:

This meeting was called for the purpose of public hearing on Zone change applications, Taxi Cab Permits and sale of City property.

1. An application for Zone change of Mrs. K. Morgan to change Lot 4, Block 34, of the Denman Addition from Zone A to Zone B, was returned to Rev. E. L. Clark, in order that he could re-submit the application to the Zoning Board for further consideration.

2. It was moved by E. A. Gibbs and seconded by D. M. Thrash, to grant R. E. Bazzoon 4 taxi cab permits. The motion carried by unanimous vote of yea. It was then moved by L. C. Martin and seconded by B. F. Milligan to grant Henry Dudley three taxi cab permits. mits. The motion carried by unanimous vote of yea.

It was moved by L. C.Martin and seconded by D. M. Thrash to reject all bids on tract out of J. L. Q. League known as Johnnie The motion carried by unanimous vote of yea. Moore Porperty.

6. It was moved by L. C. Martin and seconded by D. M. Thrash to sell the five-room house on North First Street and Humason Ave. to Mrs. G. T. Moughon at bid price. The motion carried by unanimous vote of yea.

7. It was moved by B. F. Milligan and seconded by L. C. Martin to reject all bids on lots 3 and 12, block & of J. S. Moore Addition. The motion carried by unanimous vote of yea.

8. It was then moved by D. M. Thrash and seconded by L. C. Martin, to reject all bids on the part of Everitt Addition known as the Nora Martin Property. The motion carried

by unanimous vote of yea.

•• An ordinance setting a maximum of telephone rates to be charged in the City was presented for study. After careful consideration, it was moved by L. C. Martin and seconded by E. A. Gibbs that the ordinance be passed on first reading. The motion carried by unanimous vote of yea.

10. Mr. Early reported that Koch & Fowler, Engineers, had
started a survey of the Citys' sewer system as indicated and approved in a previous meeting.

II. It was moved by E. A. Gibbs and by B. F. Milligan that a resolution be passed, authorizing the Mayor and City Secretary in behalf of the City, to borrow \$38,000.00 from the First State Bank & Trust Co., for the purchase of Right-Of-Way for proposed highway loops. The motion carried by unanimous vote of yea.

No further business was presented, so the meeting adjourned. Passed and approved this 4 day of Asbruary, 1947.
