ing business was transacted:

1. The meeting was opened with a prayer by Mayor Woodrow W. Scott.

2. The minutes of the regular meeting of March ~~20~~<sup>6</sup>, 1956 were read and approved.

3. Bids were opened for the sale of \$635,000.00, in water and sewer revenue bonds, as previously advertised, and Rowles Winston & Co., Houston, Dewar, Robertson & Pancoast, San Antonio, Dittmar & Company, San Antonio, R. A. Underwood & Co., Dallas, Shearson, Hammill & Co., Dallas, being the low and best bidders, it was recommended that such bonds be sold to ~~this~~ syndicate. The effective rate of interest for such bonds being 3.31843. A copy of bids submitted by all the bonding companies is hereto attached and made a part of these minutes.

4. It was voted by the Commission to eliminate angle automobile parking on the South side of Lufkin Avenue from East 4th Street to Timberland Drive. It was also voted to prohibit parking of automobiles during school on both sides of Raguet Street south of Denman Avenue, to Kerr Avenue, and to open such street to two way traffic.


5. The Commission ordered the publication of application of zone change by Dr. B. D. Rhodes on a lot and parcel of land on Ellis Avenue, and the application of Marvin Stubblefield for zone change on a portion of land on U. S. Highway 69. The final hearings on said applications to be had at the regular meeting on April 17, 1956.

6. Water rates for the churches of the City were discussed and it was agreed that they would be charged on the same basis as commercial and industrial users are charged.


7. Plans were approved for further improvements on Lufkin Avenue and it was estimated that such cost would amount to approximately \$22,000.00.

8. Bills for the month of February were approved and ordered paid.

9. There being no further business to come before the Commission the meeting adjourned.
