- 1. The meeting was opened with prayer by Mayor Woodrow  $\mbox{W. Scott.}$
- 2. The minutes of the regular meeting of June 19, were read and approved.
- 3. The Ordinance was passed on second and final reading, regulating the speed limits on Timberland Drive.
- 4. Publication of the following zone applications, were order for the 7th day of August, 1956, that of S. H. Purvis from "A" to "L" District on a strip of land 15 feet by 50 ft. on the North side of New Highway 94; that of Dr. Bessie Renfro from "F" to "L" District on Lots Nos. 10, 11, and 12 in Block No. 1, of the East Lufkin Addition; that of H. E. Smith from "A" to "B" District on Lot No. 9, 10 and West 47 ft. of Lot No. 8, in Block No. 47, of the W. C. Denman Addition; that of Robert Denum from "A" to "K" District on Lots No. 2 in Block No. 3, Adams Addition to the City of Lufkin.
- 5. The request of the City Bus Company to discontinue its Lufkin Land route was granted.
- 6. It was agreed to ask for a report of the Charter Committee heretofore appointed to study the City Charter.

- 7. The Gordon McCall Addition was tentatively approved. It was agreed that final approval would be given when he meets all the requirements regulating additions to the City of Lufkin.
- 8. It was agreed to rent a 25 foot lot from Mrs. Jeffie Burch, facing on Dozier Avenue, for a period of 2 years, at \$35.00 per month, to be used for parking purposes.
- 9. The Members of the City Commission expressed their appreciation for the co-operation of the public in observing the watering of yards and lawns.
