On this the 12th day of December, A. D. 1950, the City Commission of the City of Lufkin, Texas, convened in Special session, in the regular meeting place in said City, with the following members thereof, to wit:

constituting a quorum when the following business was transacted:

1 On motion of Commissioner Stegall, seconded by Commissioner Snell, the November bills as presented, were unanimously approved.

2 The minutes of the December 5, 1950 Council meeting were unanimously approved on motion of Commissioner Snell, seconded by Commissioner Zeagler.

3 Payment of judgment #8373, Annie Mae Hawk, et al vs. City of Lufkin to be disbursed as follows:

Unanimously approved on motion of Commissioner Treadwell, seconded by Commissioner Zeagler.

4 A resolution authorizing the City Manager to publish notice to bidders for construction of North Side Lift Station, and the issuance of Time Warrants in the amount of \$7,000.00, was unanimously approved on motion of Commissioner Treadwell, seconded by Commissioner Zeagler.

5 On motion of Commissioner Stegall, seconded by Commissioner Zeagler unanimous approval was voted for payment of Christmas bonuses, amounts to be determined as follows:

6 Employees on payroll for 12 months or longer 20% of one month's salary

7 Employees on payroll for at least 6 months, but less than 12 months 10% of one month's salary

8 A resolution requesting the City of Lufkin to vacate, abandon, and close Henry Avenue from Church Street on the East to Chestnut Street on the West was unanimously approved on motion of Commissioner Snell, seconded by Commissioner Zeagler.

8 A resolution proposed by City Manager Steenson relative to the extension of existing water and sewer lines in the City Limits was voted as follows:

Aye: Commissioners Stegall, Treadwell, Snell and Zeagler
Nay: Mayor Granville Wright


