The following proceedings were had, to-wit:-

The Mayor stated that the purpose of the meeting was to go over tentative budget as prepared by the City Manager, preparatory to having same published preceeding final adoption of same, and to do and perform any other business that might properly come before the meeting.

A bill of Dr. J. C. VanNuys for professional services rendered H.C. Billingsley, policeman whose hand was injured while in the discharge of his duty was presented for consideration by the Commission. After considering same it was moved by Commissioner C.A. Burke and seconded by W. A. Abney that same be placed in line for payment at the next regular meeting of the City Commission. The motion carried unanimously.

A petition signed by a number of the resident property owners on Lake Street asking that a street light be installed at the intersection of Lake Street and Banks Street was duly considered by the City Commission, after which on motion by W.A. Abney, seconded by C.A. Burke, which was carried unanimously, the City Manager was given authority to have same installed.

It appearing that at times the Mayor had to be absent from the City for various causes and that during his absence it was necessary for some Member of the City Commission to be appointed Mayor Pro Tem to perform the duties of the Mayor, on motion made by W.A. Abney and seconded by W. O. Greene, it was unanimously carried that C. A. Burke

be appointed to said position.
