MINUTES OF A REGULAR MEETING
OF THE CITY COMMISSION OF THE CITY
OF LUFKIN TEXAS? HELD SEP.
6th. 1927.

Be it remembered that on this the 6th day of September, A. D. 1927,
there was begun and holden a regular meeting of the City Commission of
the City of Lufkin, Texas, at the Municipal Office thereof in said City:
Present and presiding the following officers, to-wit: Joe C. Denman,
Commissioner of Ward No. 1 and Mayor Protem, A. M. Walker, Commissioner
of Ward No. 2, M. C. Spivey, Commissioner of Ward No. 3, E. W. Leach,
Commissioner of Ward No. 4, V. R. Smitham, City Manager, W. O. Seale,
City Attorney, and T. L. Dunn, City Secretary, when the following pro-
ceedings were had, to-wit:- (Mayor J.W. Hawkins being absent.)

Minutes of former meetings read, and on motion duly made and
carried were adopted as read.

The following ordinances were presented for passage and approval
on second reading:-

1.

AN ORDINANCE BY THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS,
AUTHORIZING THE ISSUANCE OF BONDS FOR THE PRINCIPAL SUM OF \$20,000.00
FOR THE PURPOSE OF PURCHASING A SITE AND CONSTRUCTING THEREON AN IN-
CINERATOR FOR SAID CITY, AND PROVIDING FOR THE LEVY, ASSESSMENT AND COL-
LECTION OF A TAX OF $4\frac{1}{2}$ CENTS ON THE ONE HUNDRED DOLLARS' VALUATION OF
TAXABLE PROPERTY WITHIN THE LIMITS OF SAID CITY TO PAY THE INTEREST ON
SAID BONDS AND TO PAY EACH INSTALLMENT OF THE PRINCIPAL AS THE SAME BE-
COMES DUE, AND PRESCRIBING THE FORM OF BOND.

AN ORDINANCE BY THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS,
AUTHORIZING THE ISSUANCE OF BONDS FOR THE PRINCIPAL SUM OF \$20,000.00
FOR THE PURPOSE OF PURCHASING A SITE AND CONSTRUCTING THEREON A FIRE
STATION FOR SAID CITY, AND PROVIDING FOR THE LEVY, ASSESSMENT AND COL-
LECTION OF A TAX OF $3\frac{1}{2}$ CENTS ON THE ONE HUNDRED DOLLARS' VALUATION OF
ALL TAXABLE PROPERTY WITHIN THE LIMITS OF SAID CITY TO PAY THE INTEREST
ON SAID BONDS AND TO PAY EACH INSTALLMENT OF THE PRINCIPAL AS THE SAME
BECOMES DUE, AND PRESCRIBING THE FORM OF BOND.

3.

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS,
AUTHORIZING THE ISSUANCE OF BONDS FOR THE PRINCIPAL SUM OF \$50,000.00
FOR THE PURPOSE OF IMPROVING THE SEWER SYSTEM OF SAID CITY, AND PRO-
VIDING FOR THE LEVY, ASSESSMENT AND COLLECTION OF A TAX OF 9 CENTS ON
THE ONE HUNDRED DOLLARS' VALUATION OF ALL TAXABLE PROPERTY WITHIN THE
LIMITS OF SAID CITY TO PAY THE INTEREST ON SAID BONDS AND TO PAY EACH
INSTALLMENT OF THE PRINCIPAL AS THE SAME BECOMES DUE, AND PRESCRIBING
THE FORM OF BOND.

AN ORDINANCE BY THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS,
AUTHORIZING THE ISSUANCE OF BONDS FOR THE PRINCIPAL SUM OF \$85,000.00
FOR THE PURPOSE OF IMPROVING THE WATERWORKS SYSTEM OF SAID CITY, AND
PROVIDING FOR THE LEVY, ASSESSMENT AND COLLECTION OF A TAX OF $13\frac{1}{2}$ CENTS
ON THE ONE HUNDRED DOLLARS' VALUATION OF ALL TAXABLE PROPERTY WITHIN
THE LIMITS OF SAID CITY TO PAY THE INTEREST ON SAID BONDS AND TO PAY
EACH INSTALLMENT OF THE PRINCIPAL AS THE SAME BECOMES DUE, AND PRE-
SCRIBING THE FORM OF BOND:

5.

AN ORDINANCE BY THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS, AUTHORIZING THE ISSUANCE OF BONDS FOR THE PRINCIPAL SUM OF \$125,000.00 FOR STREET IMPROVEMENT PURPOSES IN SAID CITY, AND PROVIDING FOR THE LEVY, ASSESSMENT AND COLLECTION OF A TAX OF 19½ CENTS ON THE ONE HUNDRED DOLLARS' VALUATION OF ALL TAXABLE PROPERTY WITHIN THE LIMITS OF SAID CITY TO PAY THE INTEREST ON SAID BONDS AND TO PAY EACH INSTALLMENT OF THE PRINCIPAL AS THE SAME BECOMES DUE, AND PRESCRIBING THE FORM OF BOND.

The above styled ordinances were duly passed on second reading as appears elsewhere in these minutes, the record of same being referred to for full description of same.

Several other things were discussed by the City Commission, but no record action was taken on anything.

The payment of accounts and bills was deferred until the 9th day of September, A.D. 1927, at which time a call meeting of the City Commission is to be held.
