Minutes of former meetings read, and on motion duly made and carried, were approved as read.

A. E. Percy appeared in person and by Attorney and complained that an encroachment by Jay Street North of Abney Avenue existed on property belonging to him and asked that an adjustment be made of such condition.

It was moved by A.M. Walker and seconded by Joe C. Denman that W.O. Seale, T. L. Dunn and E. W. Leach be appointed as a committee to confer with C.N. Humason, K. Hoskins et als to ascertain true facts concerning extension of Jay street North from Abney Avenue as its effects propery belonging to said A.E. Percy. The Motion carried unanimously.

gity Manager reported that certain vacancies existed on the Board of Plumbers of the City. Said City Manager was instructed to fill such vacancies as provided by the ordinances of said city.

It appearing that the Fire Department is in need of two 40 foot extension ladders, on motion duly made and carried the city Manager was instructed to place order for same at once.

Gity manager was instructed to ascertain the attitude regarding the construction of sidewalk and curb and gutter adjacent to Central Ward School by the Lufkin Independent School District.

It appearing that J. T. Arrington has an alley or street at the rear of his property fenced up, on motion duly made and carried the city Manager was instructed to serve notice on said Arrington to move said fence as aforesaid.

W. T. Mann appeared before the city Commission and made request that a certain animal (acow) helonging to him had been taken up by the City Pound Master and sold and that he considered the City should pay him for said cow. After considering his request it was unanimously decided that the law concerning the taking up of stock had been complied with and that the city did not the said W. T. Mann anything and therefore refused to pay for same.

W. O. Ricks appeared before the City Commission in person and asked that persons desiring to do plumbing in the city be allowed to do so without examination and licensing by the Board of Plumbers of the City, provided such plumbing work be done according to ordinance and pass the necessary inspection. Such request was unanimously refused.

Frank R. Flanigan appeared and asked that he be granted a gas franchise in the City. After discussion of said mater action was deferred until a future date.
