

MINUTES OF A CALL MEETING  
OF THE CITY COMMISSION OF THE CITY OF  
LUFKIN, TEXAS, HELD March 20th. 1928.

Be it remembered that on this the 20th day of March, A.D. 1928, there was begun and holden a call meeting of the City Commission of the City of Lufkin, Texas, at the Municipal Office thereof in said City; Present and presiding the following officers of said City, to-wit: E. W. Hawkins, Mayor, Joe C. Denman, Commissioner of Ward No. 1, A. M. Walker, Commissioner of Ward No. 2, M. C. Spivey, Commissioner of Ward No. 3, E. W. Leach, Commissioner of Ward No. 4, V. R. Smitham, City Manager, W. O. Seale, City Attorney and T. L. Dunn, City Secretary, when the following proceedings were had, to-wit:-

The purpose of the meeting was for consideration of additional white way extensions and additional water mains.

After much discussion of the matter relative to additions to the proposed white way, it was moved by Joe C. Denman and seconded by E. W. Leach that the white way be made to include Dozier Avenue from second street to Angelina Avenue; thence on Angelina Avenue to Cotton square; thence around Cotton Square to Angelina Avenue again. Also Shepherd Avenue from Second Street to Angelina Avenue; thence on Angelina Avenue to Cotton Square. The motion having been put by the Mayor, same carried unanimously.

There came up for discussion and consideration the passage of an order of date March 6th whereby the City agreed to pay for the power necessary to operate white way system on Ellis Avenue <sup>and Dozier Ave</sup> from Cotton Square to Maguet Street on condition that the property owners provide and install such lights. After discussion of such action by the City Commission it was moved by A.M.Walker and seconded by Joe C.Denman that such order be rescinded and revoked. The motion having been put by the Mayor, same carried by the following vote, to-wit:- Ayes- J.W. Hawkins, Joe C. Denman, A.M.Walker, M.C.Spivey and E.W.Leach. Noes- None. Whereupon the Mayor declared said order in all things rescinded and revoked.

The matter of laying new water mains was thoroughly discussed after which the City Manager was instructed to lay water mains as

follows: On the Huntington Highway to the City limits, using 4" inch Cast Iron one-half the distance beginning at Finley Avenue, and using 2" Galvanized Pipe the remaining one-half of the distance; On the Manton Road from Everitt Street to the City limits, using a 2" galvanized pipe; On Bynum Street from West Grove to California Blvd; thence on California Blvd to Texas Ave; thence on Texas Avenue to Weiner Street; thence on Weiner Street to intersect present 4" water main thereon, using altogether 6" Cast Iron pipe for same.

The City Manager recommended the consolidation of the office of Chief of Police and City Fire marshal, giving as his reason that better results could be obtained and the enforcing of the laws and ordinances relative to same could be more effectively enforced. The matter having been duly considered it is hereby ordered that the office of Chief of Police and City Fire Marshal be consolidated and that the duties of such offices be performed by the Chief of Police or under his direction, subject, however, to the orders of the City Manager and City Commission.
