MINUTES OF A CALL MESTING OF THE CITY COMMISSION HELD "ON THE Line day of February, A. D. 1926.

On this the 11th day of February, A.D. 1926, at a called meeting of the City Commission of the City of Lufkin, Texas, came on for consideration the matter of purchasing a strip of land from N. D. Wright for right-of-way purposes for the purpose of connecting Illis Avenue in the western pattion of the City with the "Iron Bridge Road" or highway extending from Lufkin west to the iron-bridge road on Neches River and known as the Iron Bridge Road", and

This Avenue without conteming or parchasing a strip of land therefor through property belonging to N.D.Wright from the city limits on the west. thence in an easternly direction to intersection with Ellis avenue, a distance of approximately feet; and that said street and highway are one of the important highways in and leading to the city of Lufkin from the desternient to be approximately and further that the State Highway Experiment will not take over and maintain said "Iron Bridge Road" unless It is connected with a street in the city of Lufkin, and

Texas, has agreed that the atty (Angelina) will grade and construct the necessary culverts on said illis Avenue from the city limits on the west thence with fills Avenue from the city limits on the west thence with like Avenue from the city limits on the west thence with like Avenue in an easternly direction to there it intersects with Ragnet direct provided the City of Angkin will procure the right-of-way through the property of the said N.D. Tright connecting said "from Bridge Road" or highway with Illis Avenue, and

Whereas, H. D. Wright has offerred to convey to the City of Lutkin, Texas, the said right-ofway over and across his said property from the end H14525

of said. "Iron Bridge Road" or highway where it intersects the city limits on the west, to Ellis Avenue, for a consideration of three hundred (\$300.00) dollars, and

Whereas, after due consideration of the matter, on motion by A.M.

Walker, seconded by W.A.Behannon that the City of Lufkin purchase said

right-of-way from the said N.D.Wright for the consideration of three hundred (\$300.00) dollars, on condition that Angelina County, Texas, Will at its own expense grade said Ellis Avenue and construct the necessary Cliverts thereon, from the said city limits on the west to Raguett Street in said city, as aforesaid.

The motion having been submitted by the Mayor requesting all members who favored same to vote "Aye" and those opposed to vote "No", and all members present voted "Aye" and none voted "No", whereupon the Mayor declared that motion unanimously carried.

It is therefore considered and ordered by the City Commission that said Ellis Avenue be so extended to connect with said "Iron Bridge Road" or highway, and that the City of Lufkin purchase said right-of-way therefor from N. D. Wright for thes aid sum of three hundred (\$200.00) dollars.

The City Manager, Hon. C. N. Humason and Attorney, Seale, are hereby requested and directed to notify the Honorable County Commissioners' County of the City Commissions' action in this matter; and purchase said right-of-way for the city of Lufkin. Texas.

There being no further business to come before the meeting, on motion duly made and carried, same adjourned.
