HELD NOVEMBER 3rd, 1931.

there was begun and holden a regular meeting of the City Commission in

The following proceedings were had, to-wit:-

Minutes of foremer meetings of the City Commission were read,
and on motion duly made and carried, were approved as read.

Officials of the Local Gas Distributing Company, through its
officials, requested that the public hearing heretofore set by the
City Commission for the purpose of obtaining certain information
for the purpose of determining waether or not a lower gas rate could
be established in the City, be postponed to November 20th, 1931 at
1:30 o'clock P.M. The request having been considered by the City
it was moved by W. A. Abney and Seconded by W. O. Greene, that the
request be granted. The motion having been put by the Mayor, same
carried unanimously.

Attention was called to a water bill charged against H. T. Jor-
dan, which accrued as a result of prospecting for oil at the Abney
Well in the northern part of the City. Said H.T. Jordan having writ-
ten a letter to the City Commission asking that same be charged off,
and not collected, and it further appearing that former City Manager
A. F. Daniel had authorized the water to be turned on without the
necessary deposit to cover same, he having also personally agreed to
see that said bill would be paid, and that he the said A.F. Daniel
had since been removed from the office of City Manager of the City of
Lufkin, Texas, by order of the City Commission, and he the said A.F.
Daniel had not paid said bill, or made any arrangement for the pay-
ment of same, it is ordered that same be charged off and no attempt
be made to collect same.

It appeared that the office of City Manager is vacant, since the removal of A.F. Daniel as City Manager, which said order of removal became effective October 31st, 1931, and that it is a Charter requirement that a City Manager be appointed, it was moved by C. A. Burke and seconded W. A. Abney, that T. L. Dunn, who is now City Secretary of the City of Lufkin, be appointed to said office of City Manager pending such time as may elapse before a permanent City Manager is appointed. The Mayor put the question, and the said motion carried unanimously.

OATH OF OFFICE.

I, T. L. Dunn, do solemnly swear (or affirm) that I will faithfully and impartially discharge and perform all the duties incumbent upon me as City Manager of the City of Lufkin, Texas, according to the best of my skill and ability; agreeable to the Constitution and Laws of the United States; and I do further solemnly swear (or affirm) that since the adoption of the Constitution of this State, I being a citizen of this State, have not fought a duel with deadly weapons within this State nor out of it, nor have I sent or accepted a challenge to fight a duel with deadly weapons, nor have I acted as second in carrying a challenge, or aided, advised or assisted any person thus offending; and I furthermore solemnly swear (or affirm) that I have not directly or indirectly paid, offered or promised to pay, contributed or promised to contribute any money nor valuable thing, or promised any public office or employment, as a reward to secure my appointment, so help me God.
