 5.0¢ per Ccf next 46,500 cu. ft.
 4.0¢ per Ccf all additional

Minimum monthly Bill: \$1.00

PAYMENT:

The above net rate shall be increased by 10% to arrive at the gross rate. All bills shall be rendered at the gross rate. The difference between the gross and net rates, representing a discount, shall be allowed for payment of bills within 10 days from date.
