MENUTES OF A REGULAR MEETING OF THE CITY COMMISSION OF THE CITY OF OF LUFKIN, TEXAS. December 7th. 1920.

Be it remembered that on this the 7th day of December A. D. 1920, there was begun and holden a regular term of the Honorable City Commission of the City of Lufkin, Texas, at the Municipal Office thereof in the City of Lufkin, Texas, Present and presiding the Honorable G. A. Kelley, Mayor, E. E. Woods, Commissioner of Ward No. 2, S. R. Parker, Commissioner of Ward No. 1, W. B. Treadwell, Commissioner of Ward No. 4, and Commissioner B. L. Zeagler of Ward No. 3 was absent. T.L. Dunn, City Secretary and Acting City Manager was present, when the following proceedings were hado to-wit:-

Minuts of forer meetings were read to the Gity Commission and by move and second duly made and carried, were unanimously adopted.

An Ordinance to probibit the riding or driving over any Streetor Streets, Alley or Alleys, Gutters, Gurbs or Sidewalks, while closed for improvements or repairs, was presented for passage, and same having been read to the City Commissioners, it was moved by Commissioner E. E. Woods, and Seconded by Commissioner S. R. Parker, that said ordinance be passed and that the rule requiring ordinances to be read at two separate meetings of the City Council before taking effect, be suspended and that said ordinance be now placed upon second reading, and that same take effect from and after its passage and publication. Mayor G. A. Kelley put the question and requested all members of the City Commission who favord the passage of said ordinance vote "Aye" and those who opposed to vote "No". The following members of the City Commission voted "Aye" - G. A. Kelley, S. R. Parker, E. E. Woods, and W. B. Treadwell, (B. L. Zeagler, absent and not voting. Whereupon the Mayor declared the said Ordinance passed and approved.

Whereas, it appeared to the City Commission that on account of the increased cost of material and the increased freight rates, all of which has become effective since the lettting of the Contract with R. B. Shearer to construct Curbs and Gutters for the City, in which said contract it was agreed to pay the said Sheraers the sum of 75¢ per lineal foot for the construction of same, that said sum of 75¢ is insufficient to pay for the construction of same.

Therefore be it resp2ved by the City Commission that after the construction of 12000 lineal feet of curb and gutters, that the sum of \$1.00 shall be paid to the said R. B. Sharer for the construction of all curbs and gutters in access of the said 12000 feet as aforesaid.

Commissioner E. E. Woods made and motion which was seconded by Commissioner S. R. Parker that the above resolution be adopted. Mayor G. A. Kelley put the question, and all members of said City Commission voted "Aye". Whereupon the Mayor declared the motion carried and the resolution adopted.

It appearing to the City Commission that the work of constructing sewer line connecting with the new sewer on South First Street to intersect or connect with the disposal plant situated in pasture of C. H. Harrell's, should begin at once, it was moved by Commissioner E. E. Woods and seconded by Commissioner S. R. Parker that the City Manager be instucted to begin the construction of said sewer line at once. The question was put by the Mayor, and each member of the City Commission voted "Aye", Whereupon the Mayor declared the motion carried and the City Manager instructed to begin said work at once.

Accounts and bills due by the City to various parties, firms and corporations were presented for payment, and it appearing to the City Commission, after having hear#d said bills read, that same had been properly audited and approved by the City Manager, it was moved and duly seconded that same be paid, which said motion was unanimousky adopted, and the City Secretary instructed to write City Warrants in payment of same.

There being no further business to come before the Commission, by move and second duly made and carried, adjournment was taken.

The above and foregoing minutes of the city Commission of the City of Lufkin, Texas, read and approved on this the 4th day of January, A. D. 1921.
